University Campus Network Procedure

Office of Administrative Responsibility:	Vice-Provost and Associate Vice-President (Information Services and Technology)

Scope:	Compliance with this University policy extends to all academic staff, administrators, colleagues, and support staff as outlined and defined in the Recruitment Policy (Appendix A and Appendix B: Definitions and Categories); undergraduate, graduate and Faculty of Extension students; postdoctoral fellows; emeriti; trainees; members of the Board of Governors; visiting speakers and scholars; third party contractors; and alumni and volunteers.

<u>Purpose</u>

To provide procedural information related to connectivity to the Campus Area Network (CAN).

PROCEDURE

REQUESTS FOR CONNECTIVITY

All requests for connectivity to the CAN and connectivity to clusters of technology infrastructure will be submitted to Information Services and Technology (IST) to review client's requirements to determine the best solution for connectivity.

EXCEPTIONS

- 1. The only accepted exception to the CAN standard is the network infrastructure required by Facilities and Operations to operate their real time control systems for building operation and utility services.
- 2. Any other requests for exceptions to the University Campus Network policy will be submitted to the Vice-Provost and Associate Vice-President Information Services and Technology (VP-IST) for consideration. The VP-IST's office will work together with stakeholders (including the requesting unit and IST) in considering such exception requests and will work towards an appropriate solution. Final decisions on requests for exceptions will be made by the Vice-Provost and Associate Vice-President (Information Services and Technology).
