TEACHING

COURSES TAUGHT | UOFA (SELECTION OF)

DES 135 Design Fundamentals I

This is a studio-based class that is undergraduate students from all departments that introduces students to essential design principles. Projects involve the communication of design responses through two-dimensional sketching, research, drafting and rendering, and three-dimensional models and prototypes.

DES 138 Design Fundamentals I

This is a studio-based class that is restricted to BDes and BFA students that introduces students to essential design principles. Projects involve the communication of design responses through two-dimensional sketching, research, drafting and rendering, and three-dimensional models and prototypes.

DES 139 Design Fundamentals II

Studio class restricted to BDes and BFA students. Further introduces students to design principles. Projects cover a range of abstract, conceptual and practical topics; projects involve the communication of design solutions through research, two-dimensional sketching, drafting, and 3D models and prototypes

DES 337/437/537 Design Practice, Space & Place

Investigates the role that design plays in the communication of messages, particularly in relation to how space and place frame and contextualize the creation and reception of these messages. Taught as a spring session travel course in Germany (Berlin & Münster), England (London), and Belgium (Brussels.).

DES 338/438/538 Critical Design: Practice, Space & Place in Berlin (2016, 2017, 2020, 2022, & 2023)

Summer term UAlberta International course taught in Berlin, Germany. It attracts students from a range of universities and students from a variety of faculties. Curriculum focuses on using the critical design framework to explore design within Berlin. Additionally supervised students undertaking practicums.

DES 483/683 Seminar on Design Issues

This is an advanced seminar on contemporary design issues in the fields of theory, criticism and professional practice. The goal of this course is to develop a student's ability to think critically about design issues, and to articulate clearly the nature and context of design problems and questions.

DES 493 Concepts and Systems in Visual Communication Design I

This studio based core course introduces students to systematic approaches to typographic, graphic and diagrammatic communication, image creation and manipulation. In addition project management and research training are furthered as well as introduction to working on client delivered briefs.

DES 494 Concepts and Systems in Visual Communication Design II

This core course provides the necessary concepts, knowledge, and practice to prepare students for the last year of study and for them to approach, conceptualise, think and articulate complex design issues. The course encourages students to apply basic design knowledge acquired in previous design courses, and allows them to explore new dimensions of design practice and consolidate habits of critical thinking in order to face new and more interconnected design problems.

DES 498 Information Design

Investigating the relationship between design and information, specifically examining: text, tables, charts, diagrams and electronic displays. User-machine interaction: perception and cognition. Visual presentation of abstract and quantitative information.

DES 595 Interactive Media I

Design issues in new communication media. Internet as an information resource, research tool and mass communication media. Navigation, interaction and interface design in hypermedia that apply to a variety of media and output devices.

DES 596 Interactive Media II

Further design issues in new communication media navigation, interaction and interface design in media. Issues of narrative, animation, usability, and complex interactivity are investigated and explored.

DES 597 Design Management

Project and office management. Design methods and evaluation, systems theory, writing for design. Introductory marketing and social marketing, motivational and audience studies.

Des 600 Concepts, Analysis and Criticism in Design I

A project-based course dedicated to introducing students to research and practice methods.

Des 601 Concepts, Analysis and Criticism in Design II

A project-based course dedicated to further introducing students to research and practice methods.

Des 680 Theory + Research in Design Studies

A course focused on introducing a wide range of theories and methods of inquiry and research in design studies; studying the relationships between research and design processes; and exploring new areas for investigation and development in design research and practice.
