### Chair's Introductory Remarks

This year is my fifth year as Chair of the Department. During my time as Chair, I have seen the departure of numerous colleagues (retirements and resignations), and the reduction of our support staff, but also the addition of four new faculty members. We have been faced with five years of budget cuts, and an administrative reorganization. Our graduate program is now facing a budget cut as well. Through it all, we have managed to maintain the delivery of our programs, but there have been course reductions. The Department's Assistant Chair and excellent support staff have ensured that the Department continues to run smoothly.

This past year has been another challenging one for the Department of Economics. The Department has been coping with reduced staff resulting from the Faculty of Arts administrative reorganization process. This has meant that our Main Office is closed from time to time due to lack of available staff to keep it open. The Department has experienced significant faculty losses, described below, that will impair our ability to deliver our programs. Due to continuing budget cuts to the Faculty of Arts, it is not clear when the Department will be able to hire sufficient academic staff to be sustainable. At the present time, we are not.

During the past year, the Department has seen the departure of Eric Stephens, who has taken up a position at Carleton University. Andre Plourde has also resigned, confirming that he will not return from his position as Dean of the Faculty of Public Affairs at Carleton University. Brad Humphreys and Jane Ruseski have taken leave in order to spend the year at West Virginia University. Henry van Egteren took leave from the Department in January in order to assume

the position of Commissioner for the Alberta Utilities Commission. More recently, Professor van Egteren's application for the Voluntary Severance Package was accepted by the University. David Ryan's application for the Voluntary Severance Package has also been accepted, although Professor Ryan will complete the current academic year before retiring. And our faculty lecturer, Sarah Dobson, has also resigned.

The Department's faculty losses, including leaves, have left it with 21.5 full time equivalent faculty members. The Department has over 9000 course registrations and over 1000 economics majors. The Department continues to rely on the essential teaching services of 13 contract instructors in order to cover its undergraduate courses.

In recognition of the Department's staffing crisis, the Department has been allowed to recruit for two entry level Assistant Professors, with starting dates of July 1, 2014. The field preference for one position is Public Economics, while the field preference for the second position is Macro/Monetary **Economics** Natural Resource, or Environmental, and Energy Economics. We are also refilling the faculty lecturer position. If successful, the Department should be back up to 23.5 FTE faculty members, well short of our peak faculty count of 37.

During the current academic year, the Department's staffing situation made it once again necessary to hire a Visiting Assistant Professor. Dr. Abdul Aleem has joined us as a one year visitor. Dr. Aleem has a PhD from the University of Paris XIII (France). He will be teaching undergraduate courses in Intermediate Macroeconomics, Money and Banking, and the Economics of Financial Markets.

A number of our faculty, staff, and students received special recognition and appointments this year. Stuart Landon

commenced his position as Associate Dean of Arts (Student Programs) in January. Dmytro Hryshko spent the fall semester at the Copenhagen Business School. Claudia Landeo received the Terry McLean Waters Alumni Award from the University of Pittsburgh. Rick Szostak continued his position as President of the Association for Integrative Studies. Corinne Langinier completed her sabbatical year visit to UPMF-INRA in Grenoble, France. Brad Humphreys continued his appointment as Editor in Chief for Contemporary Economic Policy. Denise Young was appointed to the Council of Canadians Expert Panel on Canadian Industry's Competitiveness in Terms of Energy Use.

Brad Humphreys completed his term as Associate Chair-Graduate Program. The Department is grateful for all of the good work that Brad did in this position over his three year term. And it is happy to have David Ryan take over this position for the current year.

The Department's Institute for Public Economics had another busy year, and Bob Ascah, the Institute's Director, provides an excellent summary of its activities later in this Newsletter. Bob has completed four years as Director of IPE, and resigned from this position effective October 1, 2013. The Department is very grateful for all of Bob's work on behalf of IPE. We wish him well in all his future endeavors.

Finally, I would like to personally thank all of you that have made donations to the Department, to one of its scholarships or awards, or to the Institute for Public Economics. The Department values your contributions, as they help us pursue our mission of achieving excellence in teaching and research.

### Abdul Aleem

Dr. Abdul Aleem is visiting our Department as an Assistant Professor of Economics. Professor Aleem holds a Ph.D. in Economics from the University of Paris XIII, France. His research is focused on empirical macroeconomics. His work has been published in the Journal of Asian Economics, Applied Economics and Research in International Business and Finance, among other peerreview journals.

### ADMINISTRATIVE STAFF

Several administrative changes have taken place in the department. We are happy to have Karen Buchholtz as our administrative assistant for the current academic year. She serves in both Economics and Anthropology departments. Brenda Carrier is located in the Anthropology Department for this academic year, replacing Gayeung who is on maternity leave. Chelsi Hudson and Audrey Jackson serve as undergraduate advisor and graduate advisor, respectively. Our executive assistant Charlene Hill serves as an assistant to Chairs of both Economics and Anthropology departments. Tim Khaner, our assistant chair administrator is also responsible for both departments. Michele Wilanowski is the person in the Arts Finance office serving as our internal reviewer and financial contact.

The administrative changes experienced this year represent a loss of 2.5 FTE from a staff complement of 6 a year or so ago. We have made considerable progress adopting online processes in order to cope with this reduction in support capabilities. The concept behind our administrative Google site has been also adopted by the Faculty of Arts. Similarly, our initiative of personal Google sites for faculty has been also adopted by several other University units.

We are going into a very busy time, with the search for a new Chair and a recruiting process to fill some of the seven faculty positions recently lost. The excellent support from our administrative staff will help us accomplish our teaching, research, and administrative activities.

## Institute for Public Economics (IPE) UPDATE

The Institute organized a number of public events, launched a policy series publication, and completed the Alberta labour research project.

**18<sup>th</sup> Annual Eric J. Hanson Lecture with Professor Severin Borenstein** - "What Will
It Take to Make Renewable Energy
Competitive?" This event was held on

October 26, 2012 and approximately 80 attended.

Professor Severin Borenstein is a world-renowned scholar in the fields of energy policy and competition policy. Currently he is the E.T. Grether Professor of Business Administration and Public Policy at the Haas School of Business at the University of California at Berkeley. Borenstein earned his Ph.D. in economics at the Massachusetts Institute of Technology in 1983.

Dr. Borenstein's research has been published extensively in such journals as the American Economic Review and the Journal of Industrial Economics. In addition he is a frequent commentator on public affairs in such areas as airline and energy deregulation has appeared before numerous and legislative committees. He is also the creator educational software simulating competitive markets.

Over 250 people attended the "Budgeting World in Government" symposium at the Edmonton Shaw Conference Centre on January 17, 2013. The conference was the result of IPE collaboration with the Financial Management Institute of Canada (FMI) and the Institute of Public Administration of Canada (Edmonton Regional Group). IPE Director, Robert Ascah presented "The Budgeting World in Government" — a historical overview of the role of government, how budgeting is supposed to work and the particular fiscal dilemma facing the province of Alberta.

**2013 Provincial Budget Post-Mortem** was held on March 21, 2013; 219 registered, with 73 attending (terrible snowstorm on this day), 65 watched the webcast.

On Thursday March 7<sup>th</sup>, the Honourable Doug Horner, Alberta's Treasury Board and Finance Minister, introduced the Progressive Conservative government's first budget since

winning April 2012 election. the Announcements from the government before the Budget and in the Budget underline the pitfalls of Alberta's reliance on resource revenue to fund current operating and capital expenditures. Speakers included Professor Emeritus Mel McMillan; Derek Fildebrandt of the Canadian Taxpayers Association (who braved the storm in a harrowing bus ride from Calgary), former Alberta Finance Minister Shirley McClellan, John Kolkman of the Edmonton Social Planning Council, Graham Thomson of the Edmonton Journal and Bob Ascah, Institute Director.

19<sup>th</sup> Annual Eric J. Hanson Lecture with Mark Carney, Governor, Bank of Canada, was held on May 1, 2013 with 369 attending and more watching via webcast.

On May 1<sup>st</sup>, Canada's outgoing Governor of the Bank of Canada delivered the Hanson lecture. The lecture "sold out" within 24 hours of posting and an overflow room in the TELUS Learning Centre was booked to accommodate the growing interest to attend.

## Conference "Alberta: Future Challenges" – May 13, 2013

There were 95 registrants in all: with speakers and sponsors 143 attended the full day conference.

### **Policy Series**

Under the guidance of Tilmann Klumpp, Research Director, The Institute for Public Economics released the first of a series of peer-reviewed studies designed to inform public debate on highly relevant policy issues. The first paper, authored by Ergete Ferede, Associate Professor of Economics at Grant MacEwan University and Fellow of the Institute for Public Economics, examines the critical issue of taxation policy in Alberta.

"The response of tax bases to the business cycle: the case of Alberta" examines the tax bases for personal and corporate income taxes and sales taxes from 1976 to 2008.

Future series studies will include the labour shortages report and chronic disease management health studies by Tapan Chowdhury. Professor **Emeritus** Mel McMillan is working on two papers: one addresses whether the Government of Alberta has a spending or a revenue problem and the second examines capital financing in government.

## An Examination of Alberta Labour Markets

The scope of Alberta's labour shortage and need for recommendations on how to address those shortages were the catalyst for a year-and-a-half-long study of one of the province's most pressing policy challenges. The Institute commissioned the study to

foster informed debate on the highly relevant policy issue. The research for the report was carried out by the Western Centre for Economic Research, Professor Joseph Marchand, Applications Management Consulting Ltd. and the Conference Board of Canada. Funding for the study came from three provincial government departments and more than a dozen industry and labour associations.

#### **Fellows**

In October the Director of the Institute announced the appointment of Robert Bhatia as a Fellow of the Institute. Throughout his lengthy career with the Government of Alberta, Mr. Bhatia advised on numerous major economic, fiscal, financial and policy issues as well as leading large operational organizations.

#### **Business Visitor**

January, the Institute for Public **Economics** announced that Tapan Chowdhury had joined the Institute in the capacity of Academic Business Visitor for the period of one year until December 31, 2013. After 30 years in the Alberta Public Service, primarily with the Ministry of Health, Tapan retired in late 2011 from the of Executive Director position Information and Analysis Branch. Tapan is

currently working in a part-time capacity with the Alberta Office of the Auditor General, as the Director of Health Audit Development. Through a partnership arrangement with the OAG, Tapan will be focusing on chronic disease management of health care in Alberta at the IPE during 2013-14.

#### **Status of Institute**

While conference registration fees and corporate sponsorships generated some profit to keep the Institute going, the lack of success in fund-raising through corporate and individual donations has been a disappointment. Since 2012, the Institute has relied on external funding for 100 per cent of its expenses but, to date, donations have been less than \$5000 against annual expenses of about \$70,000. Going forward the Institute will operate without a Director and administrative support. It will undertake select activity including the publication of policy papers on chronic health disease management and Alberta public finance early next year.
