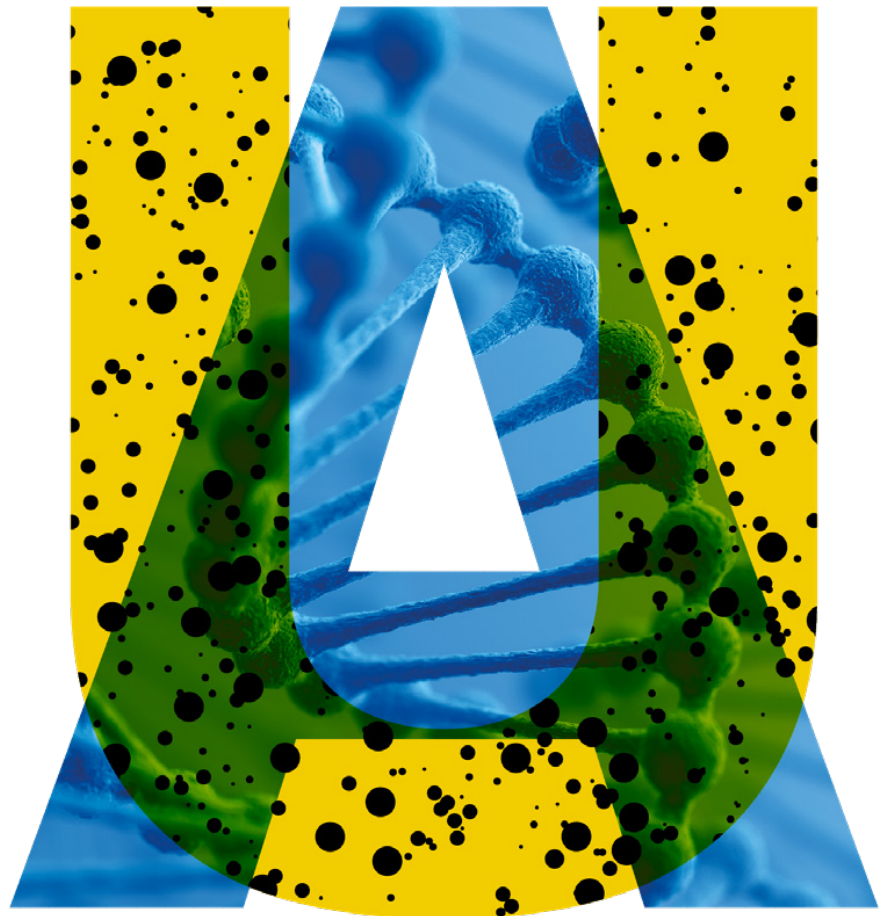

This was not an uneventful year. Our research strategic plan was created in 2019 and in 2020, working groups were established to implement the plan. You can see a brief description of our research strategic plan below. Our vision is: Engage. Discover. Change. On January 25, 2020, the first case of COVID came to Canada and was declared an emergency in the province of Alberta in March 2020.

We had to change how we worked, accommodating the situation through working from home and adapting to virtual visits. Despite this, our research program continues to thrive and grow. As you read through our research and scholarly report you will be struck by the depth and the breadth of our outputs. You will see numerous small grants received from the Northern Alberta Academic Family Physicians Fund. These grants provide a springboard for our faculty to develop skills and expertise to then develop big “R” research projects and programs as described under grants received. You may notice our ‘Research Development Rounds’ that provides a venue where academics can dialogue and share research in development, obtaining constructive feedback and support. Our published research covers clinical, epidemiological, educational, quality improvement, implementation science, program evaluation, evidence synthesis review topics, to name a few. You can see ‘tools for practice’ that provide family physicians with focused evidence updates. This popular resource is developed by our evidence-based medicine researchers. Our residents are required to complete two practice quality improvement projects during their residency, and you can view a listing of the second-year residents’ topics.

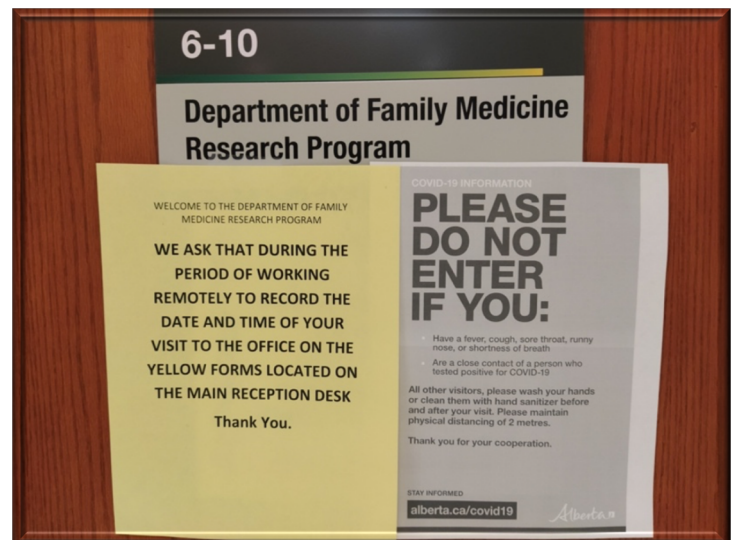
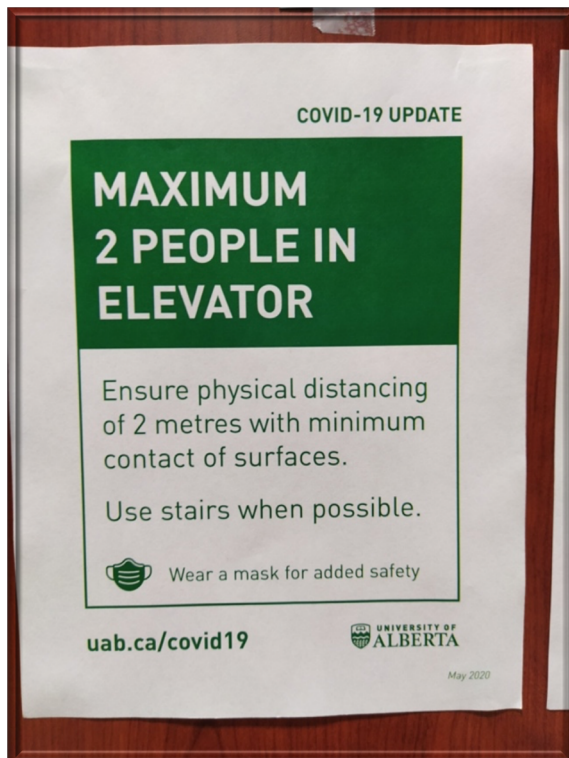
