	(PDFA), as the representative organization, have membership on this committee and an opportunity to participate in this aspect of university governance. The second addition of the Vice-Provost and University Registrar, or designee is related to the deep relationship between the two roles on matters regarding student records, fees, and academic regulations. The third addition addresses what now appears as a lack of internal representation in decanal selection from within FGSR. Currently the committee includes only one member of the support staff from the Faculty. This proposal would add one member of FGSR's leadership team from one of these categories: academic staff (Associate Deans seconded to FGSR), APO (Category A1.2) or MAPS positions (Category D1.2) whose appointments are held within the Faculty. This would add an academic or senior administrative perspective that has a day-to-day working familiarity with FGSR that is different from the other perspectives represented on the selection committee.


