# 7. <u>Calendar Change: Maintaining Registration for Course-based Master's Students</u>

Motion: Be it resolved that the Faculty of Graduate Studies & Research Council approve the proposed calendar change under 203.3.1 Maintenance of Registration – Course-based Programs: Students in course-based degree programs must register in <a href="maintenance-students-based">and successfully complete</a> a minimum of \$\dagger\*3\$ of coursework or in M REG 800 Maintaining Registration for at least one term in each September to August period to keep their program active.

#### 8. Environment, Health & Safety (EHS) Management System Project Overview

A Cooper presented the project overview which included the following information:

- Many EHS clients lack a comprehensive knowledge of various responsibilities driven by legislation, which has become more complex. With approximately 2000 labs, EHS resources cannot operate with a "hands-on" approach.
- The intention is to meet the minimum requirements of legislation with a system that is a blend of best practices which have been tailored to the UofA. The expectation is that there will be a high level of input from the university community.
- In the future, it is expected that safety leadership will start at the top and areas will own their safety performance. Everyone will know their responsibility for safety and "cue" each other on unsafe acts. Areas will report and evaluate incidents and once safety has become a mindset, all activities will become more efficient.
- EHS will be approaching the GSA for their input to improve safety in lab and high risk settings. If a graduate student, or any employee of the UofA, has safety concerns they should inform their supervisor, who must act.

#### QEII

The UofA QEII allocation amount has not yet been provided to the FGSR. It is hoped that as in 2013-14, the FGSR will be informed by the Ministry of Education at the end of May. The FGSR will notify the departments as soon as that information is available.

### Community Force

L Rose informed the Council that the framework appeared to be ready, but does not yet meet expectations in regard to consistency with the UofA's website standards for common institutional branding. Another technical challenge encountered is managing the filters for the high number of external institutions and countries where graduate students apply from so that differences in postal code, telephone numbers institutional names etcetera are recognized by the stystem.

Testing will occur in mid-May or early June, using sample applications and data with the intentionto go live in July.
