### **Course Description and Objectives:**

Pornographic, obscene, exploitative, provocative, titillating, raunchy, offensive, dirty – just some of the positively and negatively coded adjectives that might describe the visual representation of the sex act. There is little else that elicits such a strong reaction from an audience – often demands a strong reaction – than sex on screen, and little else is so dependent on and often breaks national, cultural, ethical, racial, and gendered expectations or boundaries. This course considers the representation of the sex act captured on film, video, and other forms of moving pictures. Of particular interest will be the relationship between aesthetic construction, pleasure, and performativity when sex becomes central to the visual narrative. In addition, we will examine contextual issues such as the national and ethical approach to the taboo, cultural and political implications of the changing shape of censorship, the line between pornography and art house cinema, the manner in which new medias democratize access to the means of

production, and how race, gender, and class help to shape the representation and dissemination of sex on screen. Through our examination of such 'dirty' pictures we will access and interrogate notions of acceptability, the popular, high art, exploitation, and industry machinery. This semester, the focus will be on notions of desire, marginality, selfhood, and provocation in the representation, production, and consumption of the sex act on screen. We will also interrogate medium (film, Super 8, digital camera phone) and language, including aesthetic language, of the objects at hand.

#### **Texts:**

Secondary reading will be available on reserve in the library or on Moodle, list distributed on the first day of class. It is the student's responsibility to copy the relevant essays.

Primary material will be screened during the "lab" portion of the course. If you cannot attend the lab, it is the student's responsibility to arrange for screening the films on their own time.

## **Explanatory Notes on Assignments:**

*Response dialogue*: Undergraduate students will be expected to respond to the texts and discussions held during the week in the form of an informal response journal. Each Friday a new discussion will begin on the online discussion forums. Graduate students will take turns kicking off the discussion for the week and moderating and contributing to the discussion throughout. Every Friday the previous week's discussion will close.

Short paper: Students will write a short midterm reaction paper (4-5 pages) discussing a detail from a film, a theoretical text, or from class or online discussions. The paper must have a clear thesis and have an argument. You do not need to use outside sources, but you do need to refer to one source used in the class.

*Presentations:* You will be expected to present on one of the films screened during the semester, in consultation with the professor. You will do the presentation individually and you will be expected to lead the discussion in class that day.

*Term paper:* Students will write a research paper (approx. 18 pages excluding title page and bibliography), including an abstract and **ten secondary sources**, on a topic of your choosing. Students should provide the abstract to the professor in advance for discussion during an individual meeting.
