Course Description and Objectives:

The course focuses on the literature and the other Arts of the seventeenth century, the so-called Age of Baroque in Italy and Spain but also in Germany, France and England, with reference to China and Japan. While the main discussion will be on Literature and on the allegorical writings of Baroque poets and writers, it will also provide a general idea of how the Baroque is present in painting, sculpture and architecture. Students will learn about one of the most fascinating periods in the history of culture and the reasons why the Baroque is considered today what we call our modernity.

Texts:

A selected list of works will be placed on Library Reserve.
