Course Description and Objectives:

This course examines storytelling in various medias as it intersects with the biological / biomedical body. To what extent can the different aspects of our body be singled out and narrated before we lose the sense of character, or even of self? What are the starting and ending moments of life in a story? How do language and images communicate the experience of illness, the regimens necessary for good health, or the dietary habits of the everyday? At the end of this course, students will be able to distinguish the most current conceptualizations of the body in health and medicine, and apply them to their reflections based on their own disciplinary background and methodology.

Explanatory Notes on Assignments:

The discussion tables will be performed in teams, and will focus on the readings assigned via eClass. The two written assignments (1500 words, approx.) will focus on visual media approaches. The Orals will be done individually during the last third of the semester.
