Course Description and Objectives:

This course, given in French, introduces students to the main tools and notions pertaining to the study of literature in the francophone world. The approach is twofold. On the one hand, basic methodological aspects in the approach of literature as an object of knowledge are presented -- character analysis; narration; criticism; periodization; historicity; semiotics. On the other hand, key cultural notions are progressively unfolded and explained -- literature & the nation; the institutionalization of literature; cultural centre & periphery; hybridity; the colonization and decolonization of literature; etc. At the end of this course, students will have acquired a basic though wide-ranging knowledge of the above methodological and cultural notions. They will also have enhanced their previous knowledge of the language, both oral and written.

Explanatory Notes on Assignments:

The discussion tables will be performed in teams, and will focus on the assigned readings. The two written assignments (each 1000 words approx.) will focus on visual media approaches. The team orals will focus on outlining a practical/creative application of the theory and discussions throughout the semester.
