Course Description and Objectives:			

The objectives of this course are to increase students' linguistic and writing abilities. The course will place emphasis on analytic reading and on several types of written expression, such as description, narration, argumentation, and review.

The course will be organized around three main activities: reading, analyzing, and commenting texts; practical exercises to acquire vocabulary and understand the fundamentals of stylistics; and writing assignments. The course also has an informational literacy component to enable the student to make use of library resources in an appropriate manner.

By the end of the course, students will be able to read, analyze, and comment on a variety of French language texts at an advanced level. They will be able to write their own descriptions, narratives, arguments and reviews, using an appropriate and diverse vocabulary.

Explanatory Notes on Assignments:

Compositions: The 4 compositions with a length between 500 and 600 words will be written outside of class time.

Tests: Test 1 will cover the first part of the course and Test 2, the second part of the course. Each test will be divided in 3 parts: reading comprehension and vocabulary, grammar in connection with stylistics, and writing.

Assignments: These are limited to 4 writing assignments in connection with the lesson on information literacy.

Participation and attendance: Attendance and participation will be assessed based on the use of French during classroom activities, preparedness, and active participation in class. Note that the instructor expects students to have read the relevant materials before coming to class.

All students will need to complete 4 short assignments in connection with the lesson on information literacy.

However, if a second excuse will be granted for late assignments, half of the mark assigned for this particular work will be deducted. Late excuses will **not** be accepted for any reason.
