**Course Description, Objectives and Expected Learning Outcomes:**

The course will introduce the students to selected theoretical aspects of translation and to a variety of Russian and/or Polish language written texts and styles (primarily non-literary) which they will translate as a practical exercises in translation. Class discussion will center on the linguistic and stylistic features of the selected texts and the merits of the each student's translation.

Students will:

1. Become familiar with prose styles of written Russian and/or Polish from the nineteenth through the twentieth centuries
2. Be able to correlate the styles of the selected texts with their English Equivalent.
3. Become familiar with series of translations of short literary extracts and evaluate their comparative accuracy.

Homework will consist of translations of texts and documents which vary in length and difficulty. Students will read all or parts of their individual translations for discussion by the instructor and the other students in the class. Discussion will center on style and linguistic features of source text and the quality of translation. The subject of the final project will be determined by consultation between student and instructor and will be due December 7.
