Course Description, Objectives, and Expected Learning Outcomes:

This course is designed to introduce students to a variety of issues in post-secondary teaching and learning. Based on theoretical and methodological underpinnings of instruction in higher education, we will apply these concepts in the design and completion of a variety of activities. We will develop teaching practices based on current pedagogical approaches and theories for courses on literature, film, media, etc., as well as foreign languages.

By the end of this course, successful students will be able to:

• Analyze and critique principles of communicative and task-based language teaching

- Discuss and assess techniques and strategies for teaching language skills and other aspects such as grammar and vocabulary
- Discuss and assess techniques and strategies for content courses in higher education
- Design activities and lessons for language and content courses in higher education
- Critically analyze and evaluate teaching practices

Course Format:

The objectives of this course will be met through a combination of class discussions, assigned readings, reflective papers, and assignments.

Explanatory Notes on Assignments:

<u>Participation and attendance</u>: Regular attendance and participation are essential for optimal performance in a graduate course. Each unexcused absence will result in a deduction of 5 of the 20 points assigned to the participation and attendance mark.

Since class discussions focus on the assigned readings, you are asked to prepare them carefully at home and engage in the material in a thoughtful and informed manner so that you can contribute to a productive class discussion. For every topic for which there are assigned readings, you must prepare one question or one comment that generates discussion (not a simple comprehension question). An example of an acceptable question is: "What are the pros and cons of inductive vs. deductive grammar

instruction?" An example of an unacceptable question is: "Is it important to learn grammar?". You must submit your question to the course eClass site **no later than 9am on the day of the class** and be prepared to initiate discussion of your question in class. If you do not have a question prepared by the required time above, or the question clearly shows that you have not done the readings, 1 of the 20 points assigned to the participation mark will be deducted per occurrence.

<u>Classroom observations</u>: Twice during the semester, you will observe an undergraduate class. These classes must be one content class and one language class, and must be taught by different instructors. You will be asked to observe a particular aspect of the class (e.g. teacher's language use, the learning environment...), reflect critically on what you saw, and prepare a written report (approx. five pages, double-spaced, typed). Further details to be discussed in class.

The observations will be evaluated on their completeness, the depth and breadth of the analysis and reflections, and clarity of expression. The instructor to be visited should be asked several days in advance whether s/he agrees to an observation and when you can come in. You must be punctual and courteous when visiting someone else's class, and thank the instructor afterwards for allowing you to observe their class.

<u>Leading class session and reflective paper</u>: You will be responsible for preparing and leading a class session on one technique or strategy for courses in higher education (a sign-up sheet will be posted on eClass). You will present a brief description of the technique or strategy, lead the class discussion about it, and develop and present an activity that shows the technique or strategy. A week after leading the class session, you will hand in a written reflective paper about that session (approx. five pages, double-spaced, typed). Leading the class session is worth 15% and the reflective paper is worth another 10%. Further details to be discussed in class.

<u>Language lesson plan</u>: You will design an 80-minute language lesson in which several skills (speaking, listening, reading, and writing) and language aspects (vocabulary, grammar, etc.) are integrated. You will submit the lesson plan along with a critical discussion of your pedagogical decisions. The critical discussion must be about 5 pages in length, typed and double-spaced. Further details to be discussed in class.

It is your responsibility to notify the instructor by email no later than two working days following the class which was missed. You may be asked to provide additional documentation and/or fill out a Faculty form. Regardless of the reason for the absence, it is your responsibility to make sure you are caught up with the class material.

For missed term work due to an excusable absence, the instructor has the final decision as to whether to grant an extension or refuse to accept the assignment. Missed work due to an unexcused absence will automatically be assigned a grade of zero. There will be no "extra" assignments for "extra" marks under any circumstances.

Policy for Late Assignments:

All assignments are due at the beginning of the scheduled class time, except discussion questions which are due no later than 9am on the day of the class. Students who consult in advance with the instructor regarding contingencies preventing the timely completion of an assignment may, at the discretion of the instructor, be granted an extension. In the case of emergencies, you must notify the instructor by email within two working days explaining why you could not complete the assignment on time. The instructor has the final decision on whether to grant an extension, deduct up to 5% per day of lateness, or assign a grade of zero.
