Course Description, Objectives and Expected Learning Outcomes:

Slavophilism is an intellectual movement emerged in Russia in the second half of the 19th century. It opposed the modernization and westernization begun by Peter the Great and advocated for a return to values and institutions of pre-petrine Russia and the Orthodox faith. In contemporary Russia, Neo- Slavophilism is gaining an increasing political and cultural influence. In this course, students will be introduced to the main ideas of the Slavophiles and Neo-Slavophiles, as well as the narratives they employ. Students will also will be introduced to the most significant works of the Slavophiles' opponents.

By the end of this course, students will be able to identify major ideas and narratives associated with Slavophilism; to discuss how these ideas and narratives function within the context of contemporary Russian culture. Students will be able to evaluate, integrate, and apply appropriate information from various sources to create cohesive, persuasive arguments, and to present these arguments in written form.

Course Format: The objectives of this course will be learned from a combination of independent learning and weekly remote meetings with the instructor. This course is taught in English.

Explanatory Notes on Assignments:

Weekly assignments: Students will receive weekly reading (articles, book chapters) or viewing (documentaries, films, interviews) assignments; students are expected to actively participate in class (remote) discussion/analysis.

Article presentation: Each student will present an articles/book chapter of his or her choice from a list provided; the presenter is expected to provide a comprehensive summary, and lead a discussion.

Case study: Each student will be working on a case study on the topic of his or her choice; each student will start with submitting a case study outline (500 words) and a bibliography; and will submit the final report (2,000 words) during the last week of classes.
