Course Description and Objectives:

This course introduces students to a selection of early modern and contemporary literary works across various cultural and national linguistic boundaries. By analyzing works from different genres, time periods and national traditions, the course discusses themes, writing styles, and the characteristics of genres and major periods of world literature. It covers Japanese Haiku, Romantic poetry, realist and modernist texts as well as postcolonial literature among others. The aim of this cross-cultural journey is to increase students' knowledge and understanding of various Western and non-Western literary traditions, equip them with tools of literary analysis, and teach them the basics of critical reading. The class format will be a combination of lectures and discussion. At the end of this course students will have a general understanding of major works of world literature from different time periods. They will be able to recognize and discuss characteristics of genres and major periods as well as themes and motifs in their socio-historical contexts.

Explanatory Notes on Assignments:

Presentation: This is a group activity. Form a two or three-member team, choose a novel, a short story, or an article from our reading list, sign up for it in class, and prepare a 15-minute presentation and 3 discussion questions for that session. In your presentation you should introduce the text and discuss its major themes and concepts. You are encouraged to use visual elements for your presentation. Don't forget that your presentation needs an eye-catching title.

- Please keep in mind that you cannot write your research papers on the novel or short story you have selected for your presentation.

Midterm and Final Exams:

For your midterm and final exams, you will have a combination of short answer and essay questions. The questions will revolve around the texts and discussions we have in class.

Research Paper

Your research paper (MLA style) presents a thoughtful analysis of relationships, themes, motifs, and/or literary techniques in a novel or short story. You should base your argument upon specific details from the text, but you must do more than offer an accurate description of content.

- Besides your primary text(s), you need a minimum of 3 secondary sources.
