Course Description and Objectives:

This course proposes a study of the food paradigm and some of its multiple representations and significations in the French culture and language – although not exclusively – through the analysis of literary texts (fictional and non-fictional texts) and visual media (pictorial representations, commercials and short videos). The course is structured around the problematics of life/identity and death and the crucial role those notions play in the cultural representations of food in those various media and in society. More generally, our reflection will show to what extent this everyday, cross-cultural reality can also be seen as a powerful means of bridging gaps and transcending cultural differences. This course, as a "cours intégré", is designed to improve the written and verbal knowledge of the French language, and is also meant to help students gain better

analytical skills when faced with a text or another medium to analyze. At the end of this course, students should be able to:

- Discuss the problematics of life and death in the perspective of the food paradigm.
- Interpret the link between food and identity.
- Investigate and analyze some artistic representations of food (paintings and installation art).
- Explain and describe certain cultural practices, such as entomophagy or cannibalism.
- Examine and question the representation of food given in certain commercials and manipulate and modify such representations.
- Recollect and invent culinary metaphors and neologisms.
- Collect and combine documents to present a synthesized personal reflection on the topic discussed in class.

Explanatory Notes on Assignments:

1°) Participation and attendance

Very regular attendance is expected.

In class, we will engage into <u>active</u> learning with individual and group activities. Your participation in these activities is evaluated for:

- how <u>well prepared</u> you come to class: you're supposed to prepare all work assigned for each class session (e.g. readings, homework activities),
- your spontaneous contribution to class discussions and activities,
- your use of the French language.

The marking rubrics will be provided on e-class.

Students are also strongly encouraged to use the course *Moodle* to share any of their questions on the course content and answer them. This is particularly relevant for shy students, although *all* are expected to participate orally in class.

Important note: Disruptive behaviour in class is a sign of disrespect both to the instructor and to your fellow students, and will not be tolerated. Activities, such as chatting, surfing the Internet, using or frequently checking your phone, studying for another class, etc., will result in a low participation grade. Cell phones should be turned OFF during class, and should remain put away.

2°) Short individual presentation (10 mins)

• Students will present their "madeleine" in front of the class. Detailed instructions will be provided by the professor during the first class.

3°) In class analysis of a short video

• Detailed instructions will be provided by the professor ahead of time.

4°) (Contrastive) Analysis of three documents (around 1200 words, +/- 10%)

• Detailed instructions will be provided by the professor ahead of time.

5°) Group presentation (10 mins)

• Students will give a short presentation in class, in small groups. Detailed instructions will be provided by the professor ahead of time.

6°) Final assignment (around 800 words)

• In lieu of a final exam, students will complete a final assignment. Detailed instructions will be provided by the professor ahead of time.
