Course Description and Objectives:

The course endeavours to train students to use Polish in everyday situations. Focus on the principles of applied linguistics will help students utilize the grammar and hold conversations in Polish on a wide array of topics. At the end of the course, the student will be able to demonstrate a solid competence in basic standard Polish, having developed their reading skills and oral competence. Grammar explanations and other conversation will be conducted in both English and Polish, sometimes with the help of contrastive analyses of both languages.

Texts:

Required textbook:

Małgorzata Małolepsza, Aneta Szymkiewicz – *Hurra!!! Po Polsku 1, part 2* - textbook, exercise book and 2 CD ROM. Prolog - Cracow: 3rd revised edition, 2005

Grade Distribution:

The **final grade** will be determined as follows:

- Active participation during in class and laboratory meetings (attendance, written and oral in-class exercises, etc.) 15 %
- Homework, special projects 15%
- In-class quizzes (vocabulary and grammar tests) 10%
- Midterm tests oral February 27 and written March 1 15% + 15% = 30%
- - Final Examination 30 %

Attention: WRITTEN midterm test is based on chapters 10-14 of the textbook and covers declension, conjugation, aspect and system of tenses in Polish. It consists of two parts: part 1 is a grammar multiple choice test and part 2 is a short in-class essay. During the ORAL midterm test, you will hear recordings (CD is a part of the textbook) of different talks and discussions. Then, following the audio, you will hear a question (or a number of questions) about what you just heard. For each of the questions, read the four possible answers and choose the best answer by filling in the space. Then you should be doing short conversation in pairs on topics provided before the reading week.

Final examination is written only and covers chapters 10-20 of the textbook and the exercise book.

The exam date for this class is 18-Apr-2018 (Wednesday) @ 2:00 p.m.

Explanatory Notes on Homework/Assignments:

Students will be provided with a variety of activities and tasks to do outside the classroom, and should expect to spend approximately **two hours on homework per class**. **The homework includes:**

- practice grammar exercises "Zeszyt ćwiczeń" (Exercise Book) from chapter 10 to 20, **due every Monday class**
- four short written assignments (between 250 and 500 words on topics related to the course material. Topics TBA) <u>due on January 18, February 8, March 15</u> and March 29

Written homework will be collected at the beginning of class. LATE HOMEWORK WILL NOT BE ACCEPTED.

In this course

Attendance will be taken at every class meeting. Students are required to attend classes regularly. They should arrive prepared and on time. Many evaluation procedures will take place during regular class time and cannot be made up, except under exceptional circumstances. **Late arrival in class:** Inasmuch as the beginning of each class is extremely important, it is mandatory that students arrive in class on time. In the case of a

10 minutes tardiness (or less), attendance will be credited. Beyond the first ten minutes, tardiness will be treated as an absence.

Unexcused absences will affect the student's grade. In this course regular attendance is imperative, therefore students who miss more than five days of classes will seriously undermine their performance.

Policy for Late Assignments:

Late assignments, including writing quizzes, will be allowed only in cases with valid reasons. Students who consult in advance with an instructor regarding contingencies that prevent the timely completion of an assignment may be granted an extension at the discretion of the instructor. Otherwise, assignments may be handed in one class-day after the stated deadline without penalty, with a 5%-per-class-day penalty assessed for each subsequent class-day of lateness.
