## Course Description, Objectives and Expected Learning Outcomes:

C LIT 102 ranges across global literature from 1700 to the present day, examining major genres and periods, with particular emphases on the socio-political and cultural importance of selected works and on what constitutes "world literature" in the early twenty-first century. The course aims to develop the literary-critical acumen of students and to help them achieve advanced understanding of canonization practices and how "world literature" constructions are justified. Students should come away from the course with a personally defensible view on what "world literature" is for them, having honed their writing skills. Furthermore, at the end of this course, students will be able to:

- **Identify** and define major thematic concepts in world literature
- **Recognise** the works of world literature and key authors

- **Identify** thematic connections between texts
- Effectively **articulate** personal responses to course materials
- **Develop** critical thinking tools in order to devise original ideas and interpretations of texts
- Evaluate theoretical works in relation to your own stance on a particular topic
- **Analyze** literary and popular works in relation to their form, content, (and/or medium)

### **Explanatory Notes on Assignments:**

**Attendance & Class participation:** Students are expected to take an active role in class, ask questions and engage in and contribute to class discussions every session. In addition, class activities will be offered every week and their participation in the forms of pair/group discussions and individual/group written reports will be evaluated throughout the course.

**In-class short essays:** Students receive questions from the assigned texts to answer in a few lines to one paragraph at least 3 times throughout the semester.

**Response paper**: Students are expected to hand in one response paper (600-800 words) written on one title from the reading list posted on eClass. Students are supposed to answer one critical question in a chosen text based on specific topics and themes introduced each week. This response paper should be handed in on designated dates throughout the term (see reading list).

**Midterm exam:** The midterm for this course will take place on **27 February** in class. The midterm exam will cover readings from the first half of the term and will consist of questions such as multiple choice, true or false, fill in the blanks, short answers, long answers, passage identification and analysis, and/or definition of terms.

**Final exam:** The final exam for this course will take place on **25 April at 9 a.m.** The final exam will cover readings from second half of the term will consist of questions such as

multiple choice, true or false, fill in the blanks, short answers, long answers, passage identification and analysis, and/or definition of terms.
