Course Description Objectives and Europeted Learning Or	4

**Course Description, Objectives and Expected Learning Outcomes:** 

C LIT 352 Throughout history, literature has maintained close relations with various other arts. Using an interdisciplinary perspective, this course emphasizes contacts and commonalities, but also the specific differences of art forms and the media. This time the course will focus on the STREET as represented in text (Baudelaire to the Beat Generation to Murakami), film (Vertov to Wim Wenders to Guy Maddin), photography

(Cartier-Bresson to Daido Moriyama to Martin Parr), and commercial and fashion ads. Interdisciplinary in its scope, this course explores literature and visual media by authors and artists of various national and ethnic cultures. Depictions of the street culture will be discussed in the context of contemporary debates on consumption, globalization, social structures, identity, race and gender. The course will include several guided visits to museums and galleries at the U of A and beyond. Along with more traditional written and oral assignments, students will be encouraged to complete more creative tasks, such as staging an exhibit related to representation of the street in various media.

#### **LEARNING OUTCOMES:**

At the end of this course, successful students should be able to:

- 1) Identify key concepts and leading theorists in the field of Urban Studies and related areas (The Street and/in the City; Urban Culture History (Avant-Garde to now); The Street in Film; The Street on Stage; The Street in Photography and Advertisement; Urban Culture Blogs; Gendered Street; Global Cities; The Street and Style Subcultures).
- 2) Discuss major issues within the discipline of Urban Studies and related areas (as above).
- 3) Along with more traditional written and oral assignments, students will learn to complete creative tasks (art exhibits, short photo/video presentations).
