Course Description and Objectives:

This course is a research practicum for students studying modern languages and cultures. This is not a course about a particular discipline or field of study; it is a course about "how" to do research. Our ultimate objective is to create a half hour podcast that questions conventional narratives of history, bringing marginalized voices to the fore, and debunking old myths. Students will be exposed to:

- Research methodologies in journalism and humanities
- The basics of research ethics
- Theoretical notions of "truth"
- Narrative plotting, story arcs, storyboarding
- Interview techniques
- Audio production basics on Hindenburg Journalist (free download available)

Objectives. Successful students will be able to do the following:

- Adopt a research methodology
- Understand the basics of research ethics
- Explain different notions of "Truth" (positivist, postmodern, postcolonial, etc.)
- Conduct an interview and mix it on a audio production platform
- Have a 30 minute podcast they can "pitch" to a radio station or podcasting media company

Explanatory Notes on Assignments:

Ten weekly assignments (50% total)

Roughly each week (excepting week one and last two weeks), students will have to complete an assignment by class time on Thursday. These assignments will serve as building blocks for the final project. Some assignments will be simple quizzes, some short writing assignments, and others might include fieldwork, annotating bibliographies, or formulating a research ethics application. Presentation (10%) For the presentation, students will present their final projects for 10 minutes.

Class Participation (20%)

This grade evaluates physical presence in class as well as engagement with discussion and lecture. For example, if you leave your screen black and never participate in chat, this grade will suffer. Students will evaluate their performance on the last day of class. "80% of life is showing up"
