Background

- Wide use of cannabis for medicinal purpose – pain, nausea, arthritis, anxiety, sleep issues, and depression.¹⁻³
- Legalized in Canada for health reasons in 2001.^{4,5}
- Still considered as an illicit drug.⁶
- Stigmatization—prevents discussion of its use— end up accessing cannabis from illicit providers.^{7,8}
- Inadequate information about cannabis— leads to consequences (e.g., consuming wrong dosage of cannabis—health impacts).⁹
- Need to focus on enhancing safe use of cannabis.



Aim

- To understand older adults' perceptions of their information seeking and access to cannabis for health reasons.



Methods

Design

- Descriptive survey

Sampling & Participants

- Purposive sampling
- Canadians ≥ 60 years, cannabis users or prospective users

Recruitment

- Flyers posted in various platforms (CanAge, HelpAge, retail stores, cannabis dispensaries)
- Interested participants self selected to participate by contacting the researchers
- Screened for eligibility

Data collection

- Data collection: Eligible participants were sent online survey link via email –completed the online survey

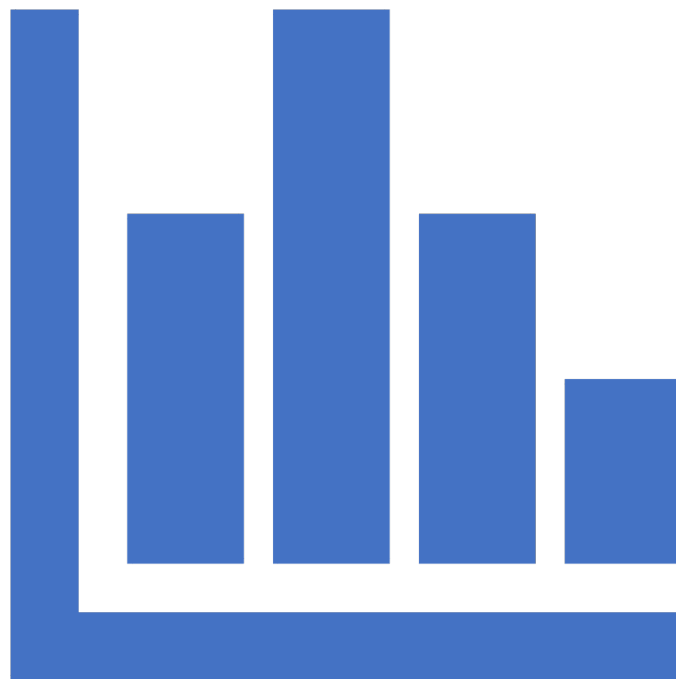

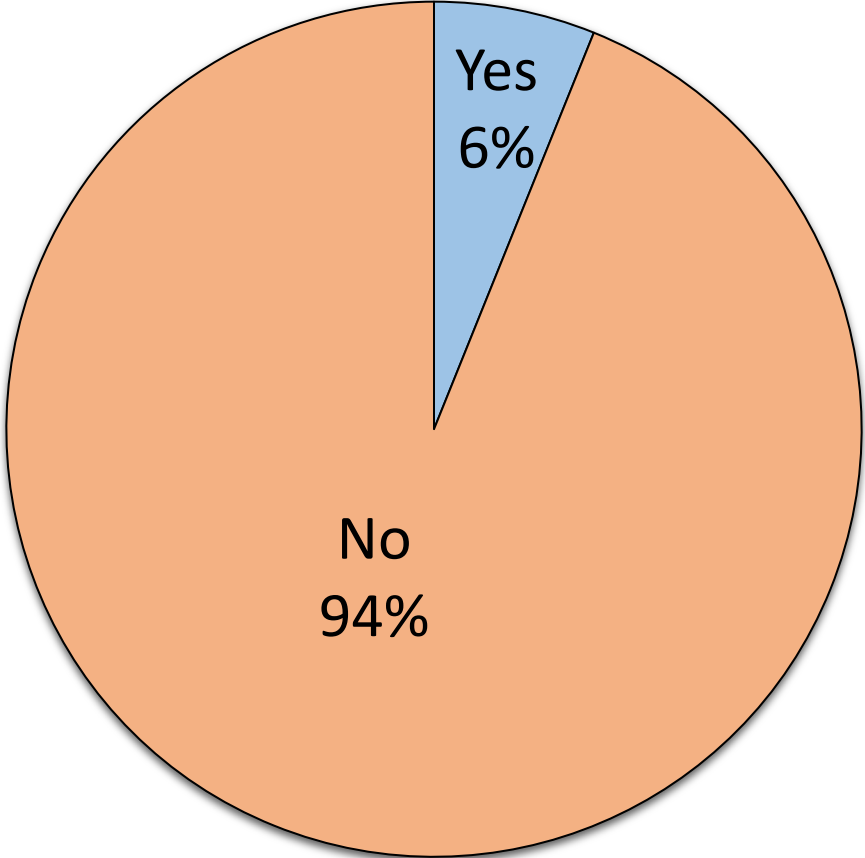

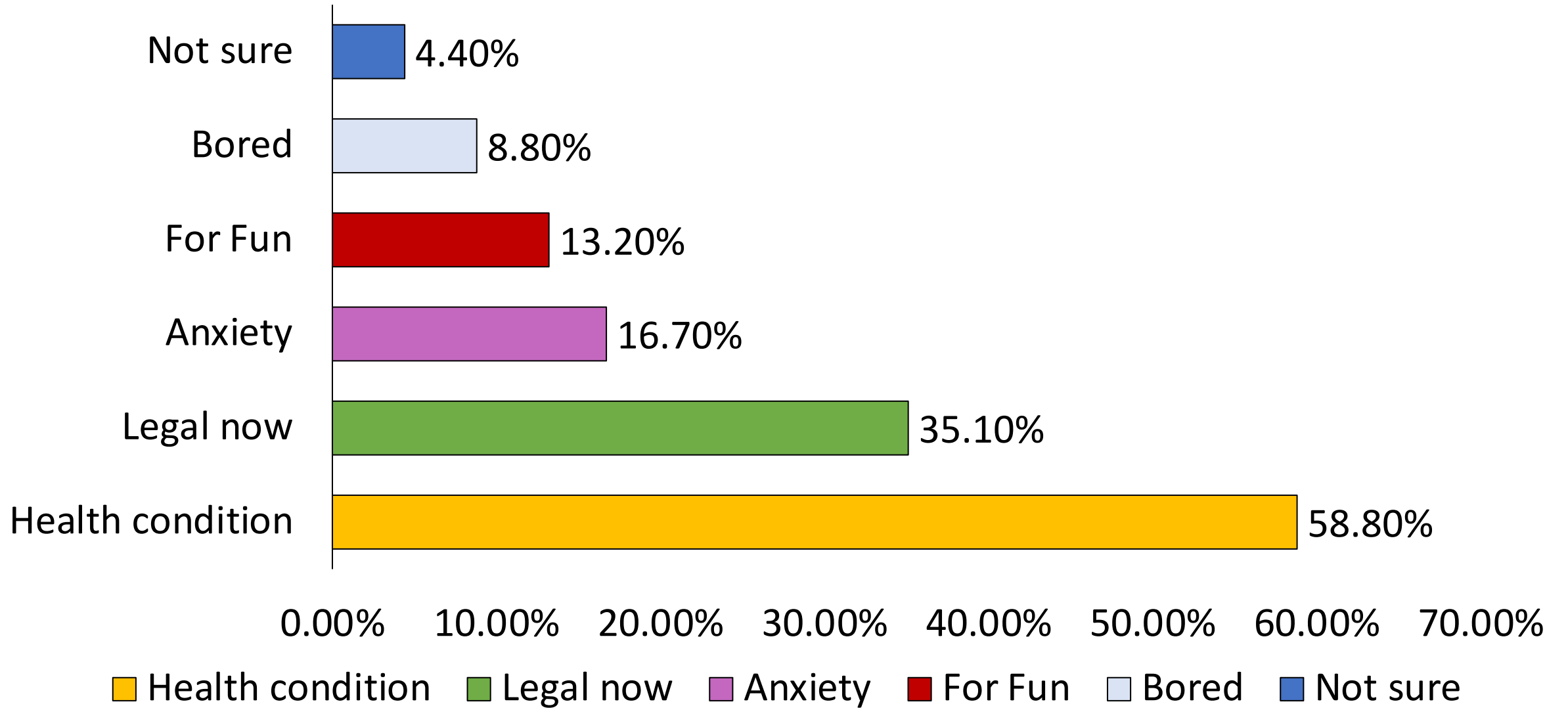

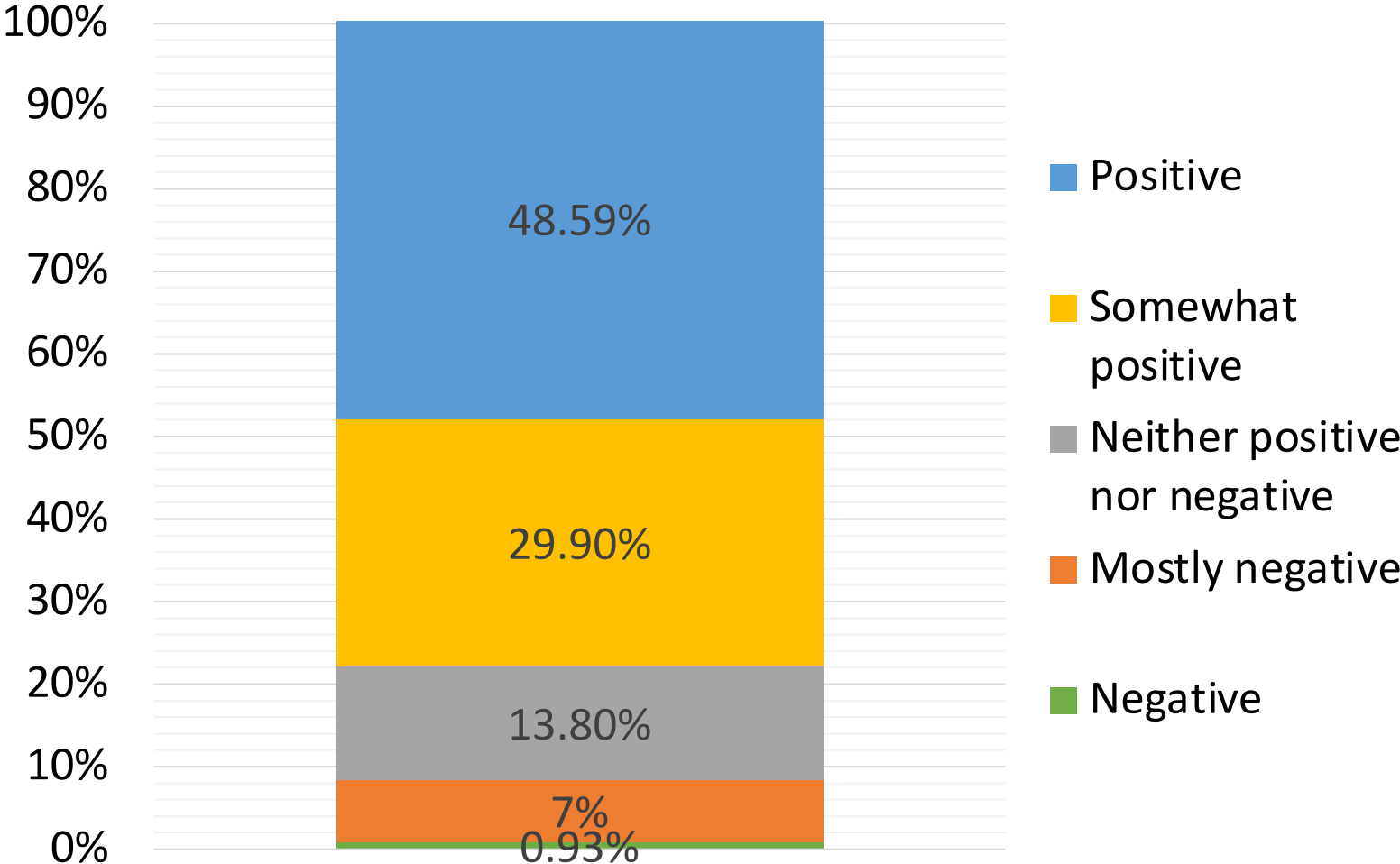
Used cannabis in the past?



Motivations to use cannabis (N=114) *Multiple response question

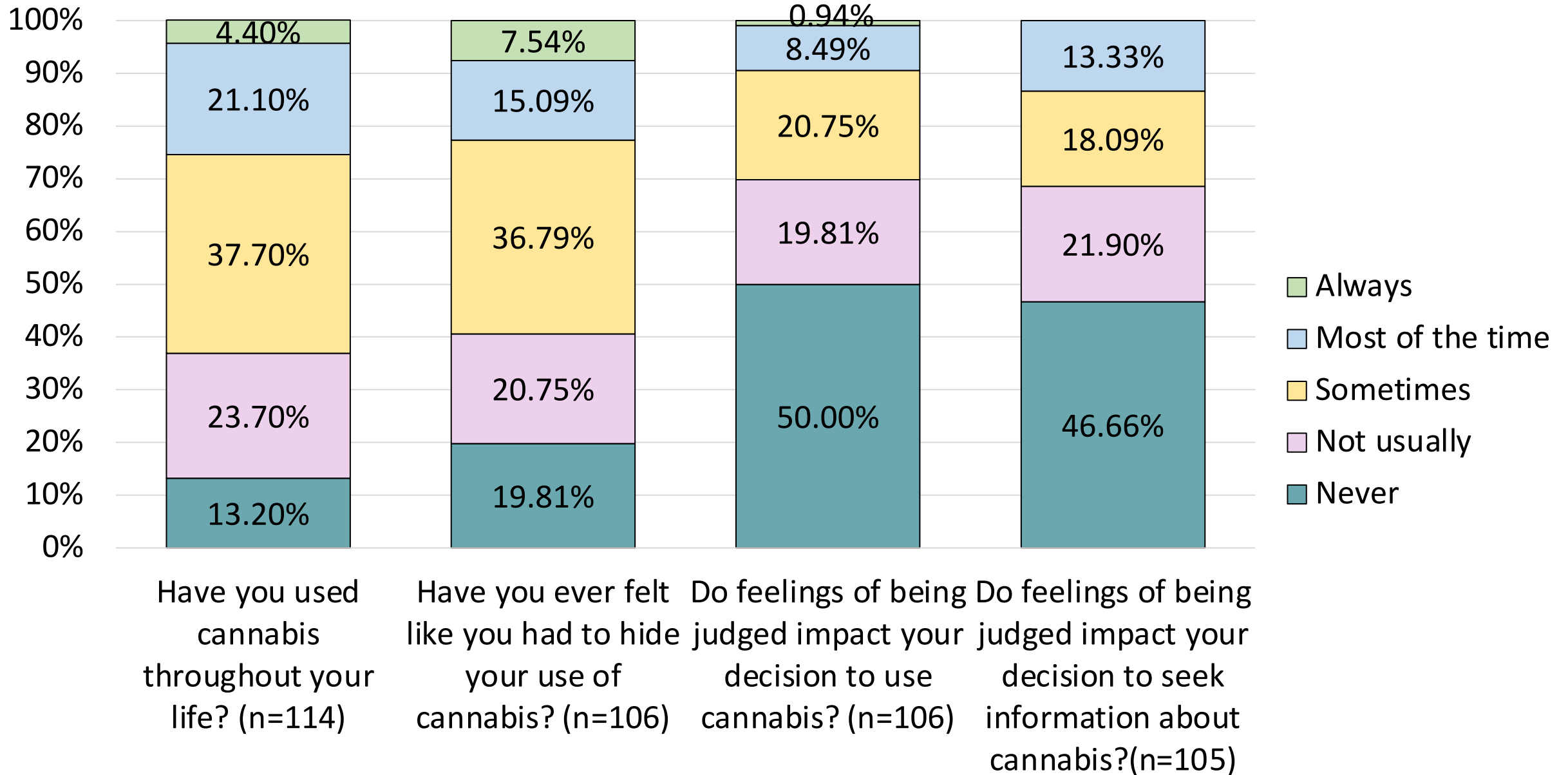


General experience with cannabis

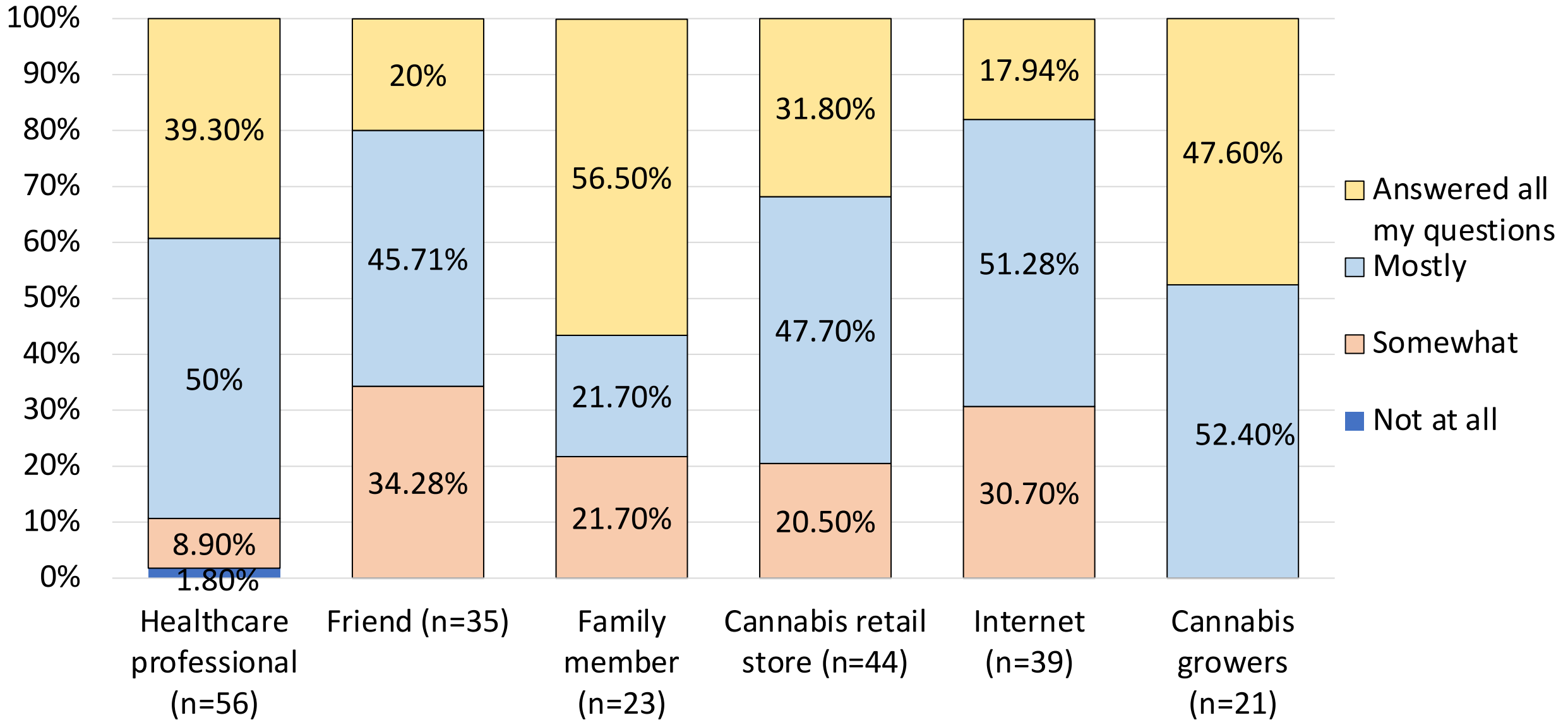


What was the experience like? (n=107)

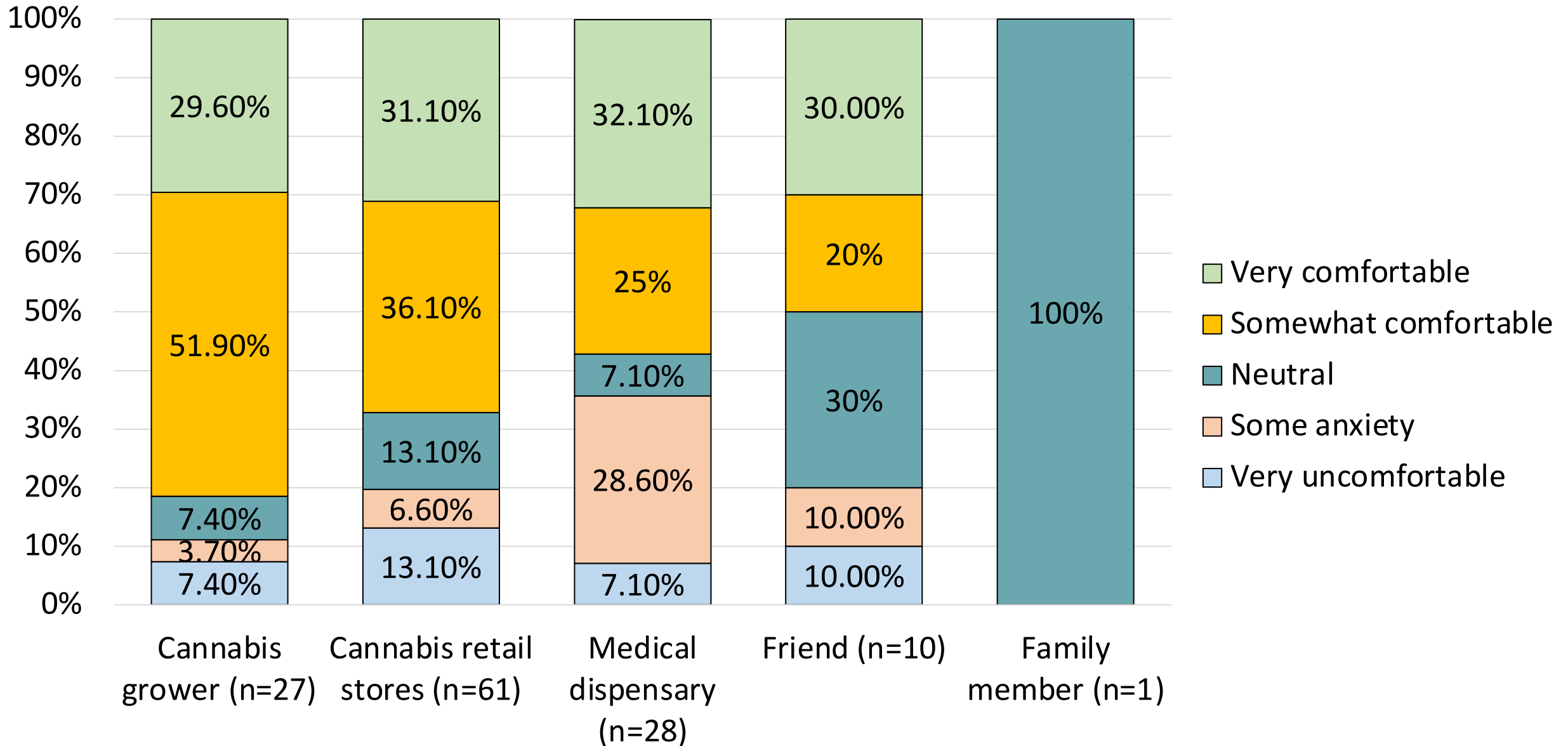
Cannabis use and judgement

Conclusion

Majority had positive experience

Most accessed information through health care professionals followed by retailers, internet, friend, family members and cannabis growers

Majority accessed cannabis via cannabis retail stores followed by medical dispensary, cannabis grower.

Older adults still feel uncomfortable accessing information and cannabis.
