documents to start working on. This change is expected to streamline the process and ensure that all financial records are properly maintained.

The Presidential Review Board of the U of A has requested the PDFA's review of the current U of A President in four major areas.

- Institutional growth and the promotion of the University's strategic direction and objectives
- Maintenance and enhancement of both internal and external stakeholder relationships
- Fiduciary oversight of the institutions' operational portfolios
- Other strategic operational, administrative, or managerial capacities initiatives

Alsayed would like to bring forward better ways of managing the PDFA's money, and how they can produce revenue. This may also include the PDFA starting to invest their money.

He has also brought forward an advocacy training opportunity that will be produced by the Canadian Association of Postdoctoral Scholars. The deadline for registration is the 26th of April.

12. VP Internal Report (MD Shaheen)

MD expressed concerns that postdocs are not eligible for pensions, but Terry explained that it would be difficult as postdoc positions are typically short-term in nature. Terry has suggested taking that into collective bargaining when the time comes to bargain for the postdocs.

VP Communications Report (Henry Prown

Henry and Alivia have been working on the PDFA spotlight project. He has also posted the orientation on the Facebook and LinkedIn pages.

Henry applied to join the board of the NGO he volunteers for, which teaches refugees English. He intends to create more volunteer opportunities for Postdocs at the location.
