The Faculty of Nursing invites applications from current employees of the Faculty of Nursing, for a Tier 2 Canada Research Chair. Applicants must currently hold a tenured or tenure-track position at the Assistant Professor or Associate Professor rank.

The COVID-19 pandemic has highlighted the challenges in ensuring high vaccine uptake and the need for equitable access to vaccines. This Tier 2 CRC in Applied Pediatric Immunization Research, will build on the University of Alberta's existing strengths in vaccine development by advancing knowledge generation in applied immunization research to improve vaccine policy and practice, particularly for pediatric immunization. Nurses play a critical role in this activity and nurse researchers are well positioned to be world leaders in applied immunization policy and practice research.

### **Duties and Expectations:**

The CRC will be an exceptional emerging nurse researcher in the area of applied pediatric immunization research who is, or has the potential to be, a national/international expert in the field. The successful candidate will be expected to lead an innovative and productive research program that identifies populations with sub-optimal vaccine uptake and develops tailored interventions focused on reducing inequities in vaccine access and uptake. The candidate is expected to conduct research that guides relevant immunization policy and practice innovations. The successful candidate will be expected to build capacity in immunization-related nursing research and representativeness in the nursing academic workforce through supervision of trainees who identify with under-represented populations, including Indigenous students and members of racialized populations.

### **Qualifications:**

The successful candidate will hold a PhD in nursing, population and public health, or related field. Hiring preference will be given to candidates who have received a minimum of two years of postdoctoral training. The candidate must have proven expertise in working with both quantitative and qualitative data sources, including administrative health data, surveys, and interviews. The successful candidate must demonstrate

active involvement with national immunization research associations, immunization advisory committees, and provincial immunization program and policy organizations. The applicant should have a track-record of interdisciplinary collaboration, with hiring preference to candidates with adjunct positions in other health disciplines, such as public health and medicine. The successful candidate will have an exemplary track record of research collaborations with policy, clinical, and community organizations. Hiring preference will be given to candidates with previous experience collaborating with Indigenous communities. The successful candidate must have current and in good standing, registration with the College of Registered Nurses of Alberta.

## **CRC Requirements:**

Tier 2 CRCs are intended for exceptional emerging researchers (i.e., candidates must have been an active researcher in their field for fewer than 10 years at the time of nomination). Applicants who are more than 10 years from having earned their highest degree (and where career breaks exist, such as maternity, parental or extended sick leave, clinical training, etc.) may have their eligibility for a Tier 2 Chair assessed through the program's Tier 2 justification process.
