# PRESIDENT'S REPORT

# TO THE GENERAL FACULTIES COUNCIL

I want to begin with warm thanks for your enthusiastic participation in this year's Joint Summit of the Board of Governors, General Faculties Council, and Senate on January 25. I found it energizing to work together on developing our voices and messages as advocates for Alberta's post-secondary education sector. The ideas from our discussions have been captured in the PSE Advocacy Toolkit distributed to you earlier in the month.

Throughout the winter, we have been moving through the university's annual budgeting process within our new multi-year planning and accountability framework. At the same time, we continue to pursue university-wide strategic initiatives—the new Equity, Diversity and Inclusivity Strategic Plan, for instance, launched in February.

Lastly, I would like to draw your attention to a few recent highlights, each of which points to larger projects unfolding over the coming months:

- University Relations' brand audit initiative—mentioned in previous reports—has now moved on to the quantitative research phase.
- The Research at the Intersections of Gender Signature Area is preparing for an official launch event at the end of March.
- The U of A is one of 16 institutions participating in a Canadian pilot of the Carnegie Community Engagement Classification—a project that will unfold over the next couple of years.

In February, we announced a new milestone in our history with the launch of the <u>EDI Strategic</u> <u>Plan</u>. Immediately following is <u>EDI Week</u>, which runs from March 18 – 22. This year's program ranges from keynote presentations to performing arts, and will include a celebration for our 2018 EDI Award recipients. I encourage you to join in both of these week-long events.

# U of A Brand Audit

Last semester I reported on University Relations' <u>brand audit initiative</u>. We completed much of the necessary qualitative research throughout the fall, and I want to thank those members of GFC who participated in the focus group in September. University Relations has now engaged the Strategic Council, a firm that conducts market research for universities, for the quantitative phase of the audit. # Alberta Cup

Each year, the five members of the Alberta Universities Athletic Association (Alberta, Calgary, Lethbridge, MacEwan and Mount Royal) compete for the <u>Alberta Cup</u>. The trophy is awarded at the end of the season to the university that achieves the most success against its provincial rivals. I am proud to report that the Golden Bears and Pandas have won the 2018-19 Alberta Cup—the third consecutive victory for U of A athletics.

Golden Bears and Pandas Athletics continue to play an important role in bolstering the overall student experience at the U of A. Please join me in congratulating the program on their success.

# Mountains 101 and Indigenous Canada

In the few years that have passed since the launch of Dino 101, Massive Open Online Courses have proven themselves a popular platform for extending the reach of U of A programming and expertise. Last year, Indigenous Canada—which explores Indigenous histories and contemporary issues in Canada—became the <u>most popular course in the country</u>. More than 31,000 people have registered for the course to date.

Most recently, Mountains 101 received high acclaim when Class Central—an aggregator of more than 11,000 MOOCS from the world's top universities—ranked it the <u>third highest-rated MOOC in</u> <u>the world</u>, as well the highest-rated course among science MOOCs last year. Nearly 26,000 people have registered in Mountains 101.

We strive not only to provide our students with exceptional experiences, but to open doors to a lifetime of learning experiences by expanding access to—and engagement with—the U of A.

# Surgery 101 Podcast

*Surgery 101*—the free surgery podcast that has generated more than five million downloads across the globe—has launched <u>a new podcast series</u> aimed at teaching children about their bodies and sparking early interest in health careers. Like its predecessor, *Surgery ABCs* enables anyone around the world to use these U of A-branded podcasts for free in classes, seminars, presentations and workshops.

# Funding New Technologies

U of A researchers support and generate innovation, and their expertise continues to attract a diversity of investors. Two recent examples stand out:

In January, Alberta Innovates <u>announced \$20.4M in funding</u> for 29 projects across the province through its Clean Technology Development program. Half of those projects are led by the U of A.

Then in February, <u>NanoFAB received \$3.4M</u> to expand its capacity to commercial scale. This support came through the federal and provincial governments, and through Micralyne Inc.

# Research at the Intersections of Gender Launch

I invite you to join me for the official launch of our Signature Area, Research at the Intersections of Gender, on March 28 at Telus Centre.

The 2019 SingularityU Canada Summit will be hosted in Edmonton this April, and the U of A is supporting the event. Our involvement is a natural fit, as the U of A is home to world-class researchers in each of these fields. The summit provides a strong global platform to showcase their expertise.

Part of this task has been directed towards rescission of the current GFC Policy Manual Section 111 Teaching and Learning and Teaching Evaluation and creation of new UAPPOL policies to support teaching and learning and teaching assessment and evaluation.
	CLE concluded that this would be best accomplished by transitioning the existing GFC Policy into several policies and procedures. The first is a Teaching Policy, and the second a separate Teaching Evaluation Policy. Cascading under the Teaching Evaluation Policy, there will be procedures around the evaluation of teaching.
	The proposed Teaching Policy, presented at this time for early consultation, underscores the University's commitment to teaching activities.
	The Teaching Evaluation Policy suite will come forward in due course with associated procedures which will speak to multi-faceted evaluation, including student feedback on teaching.

# **Teaching Policy**

#### Overview

The university has at its heart several overlapping goals which contribute to the uplifting of the whole people: the creation, dissemination, and preservation of knowledge, and the education of citizens in order to thrive and to tackle local, national, and global challenges. This interdependence and integration of teaching and research is what distinguishes a university from other educational institutions. Although the balance between these activities may vary, all members of the university, whether scholars or students, are learners who extend the range of their knowledge through questioning, exploration and discovery.

The University of Alberta is a large, teaching and research intensive institution that emphasizes the seamless relationship of scholarly activities. Our scholars share with students a rich knowledge of the discipline and its place in the larger intellectual community while actively reflecting upon, measuring and innovating their teaching practice. We are committed to providing respectful, supportive and inclusive learning environments with purposeful opportunities for collaborative interactions, while recognizing that the learning process is a shared responsibility with the students.

Teaching is a complex practice, with no single approach to serve all disciplines and settings. Development of new teaching models should be grounded in an understanding of how people learn, should be evaluated by those who are sensitive to the particulars of the teaching environment, and the final arbiters should be the promotion of student learning, student engagement, and academic excellence.

# Purpose

The policy underscores the University's commitment to teaching activities.

# POLICY

GUIDING PHILOSOPHY OF UNIVERSITY TEACHING AND LEARNING

Our primary roles are to educate students to the baccalaureate level, and to educate and mentor graduate students and postdoctoral scholars. The University of Alberta will also make our faculty and courses available to continuing, professional, and lifelong learners.

The University's commitment to teaching will be demonstrated through:



- a. Fostering in students the graduate attributes and skills defined by the University.
- b. Regular and ongoing review and revision of programs and outcomes.
- c. Provision and regular review of instruments for student feedback on teaching.
- d. Provision and regular review of supports and instruments for the formative and summative multifaceted evaluation of teaching.
- e. Acknowledgement and reward of excellent teaching.
- f. Provision of professional development in teaching and scholarship for instructors.
- g. Ongoing support for the Centre for Teaching and Learning.
- h. Fostering inclusive, supportive and accessible learning environments.
- i. Continued renewal of teaching and learning infrastructure.

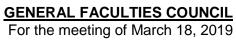

This did not align with the approval authority for other programs wherein APC is the final approver.</li> <li><u>Change in responsibility</u>: The responsibility to recommend to GFC on policy directions for teaching and learning will be moved to the terms of the Committee on the Learning Environment (CLE) rather than having CLE recommend to APC and APC recommend to GFC.</li> <li><u>Change in responsibility</u>: The responsibility for the establishment of or change to general university admission or transfer policies affecting students will lie with ASC to recommend to GFC for approval rather than ASC recommending to APC who recommends to GFC</li> <li>As an expanded responsibility, ASC will be reviewing new, and revisions to existing, programs and providing comments to APC.</li> <li>Enrollment and Planning has been revised to reflect current activities.</li> </ul>

- 1 graduate student from GFC

NOTE: One academic staff member of the GFC Academic and Research Planning Committee will be elected by the committee for cross appointment to the GFC Facilities Development Committee

Should be reviewed at least every three years and reported to GFC.

  - c. Approve certificates from all Faculties, and new non-credit programs and program expansions in the Faculty of Extension, as recommended by ASC, where additional funding and/or space is required

  - a. Approve the establishment and termination of endowed and funded chairs
  - b. Academic Centres and Institutes
    - Approve the establishment of academic centres and institutes
    - Receive notification of the suspension or termination of academic centres and institutes from the Provost and Vice-President (Academic)
- 4.3 Academic and Academic Service Units
  - a. Approve name changes to Departments and Divisions
- 4.4 Annual Budget
  - a. Recommend to the Board of Governors on the academic and research implications of the annual budget, excluding budgets for ancillary units.

- c. Receive, discuss, and provide feedback on processes for quality assurance and unit reviews.

# 5.6 Enrolment Management

- a. Receive, discuss, and provide feedback enrolment reports.
- b. Recommend to GFC on enrolment management processes.
- 5.7 Facilities Planning
  - a. Receive advice and comment from Facilities Development Committee (FDC) on any facilitiesrelated matter including requests for additional space or major new construction projects which may affect academic programs.
  - b. Informed by advice from FDC, recommend to the Board of Governors on policy matters regarding the planning and use of physical facilities.
  - c. Informed by advice from FDC, recommend to the Board of Governors on policy matters regarding the use of land owned or leased by the University.
  - d. Informed by advice from FDC, recommend to the Board of Governors on policy matters regarding standards, systems and procedures for planning and designing physical facilities.
  - e. Informed by advice from FDC, recommend to the Board of Governors on matters regarding planning and use of physical facilities where these facilities are deemed to have a significant academic or research implications or financial impact on the University.

# 5.8 International Policies and Initiatives

- a. Receive, discuss, and provide feedback on annual reports and future plans.
- 5.9 Indigenous Policies and Initiatives a. Receive, discuss, and provide feedback on annual reports and future plans.
- 5.10 Information Technology Policies and Initiatives
  - a. Receive, discuss, and provide feedback on annual reports and future plans.

# 6. Sub-delegations from Academic and Research Planning Committee

Should be reviewed at least every three years and reported to GFC.

# 6.1 Academic Programs – Graduate Degree Specializations

All proposals for establishment, suspension and termination of graduate degree second level specializations shall be submitted to the Dean of the Faculty of Graduate Studies and Research. The Dean, after consultation, may approve proposals which do not involve base operating or capital funds; the Dean will report these approvals to ARPC.

# 7. Limitations to Authority

The following further refines or places limitations on authorities held by or delegated to ARPC:

# 7.1 <u>Academic Programs</u>

a. In cases where a new program proposal represents a new credential for the university, final approval resides with the Board of Governors.

# 8. Reporting to GFC

The committee should regulary report to GFC with respect to its activities and decisions.

The committee should report annually to GFC on programs approved.

# 9. Definitions

The determination of what constitutes a "significant academic or research implication or financial impact" will be made by the Committee, either through an expression of consensus or a vote.

<u>Substantial Group of Students</u> – any one (or more) of the following three classes of students: (a) undergraduate students, (b) doctoral level students, and/or (c) graduate students pursuing studies other than those at doctoral level

<u>Academic Units</u> – include Faculties, Departments, Schools and divisions. Divisions are defined as academic units with authority over student programs. They may be budgetary units and may or may not be part of an existing Department.

<u>Academic Centre or Institute</u> – An academic centre or institute exists at the University of Alberta and is controlled by the University of Alberta. An academic centre or institute may exist solely within the University of Alberta or may be created through a partnership between the university and other entities. Such other entities may include other universities, governments, public authorities (such as health authorities), and non-profit organizations.

<u>Academic staff</u> – as defined by the <u>Recruitment Policy (Appendix A) Definition and Categories of</u> <u>Academic Staff, Administrators and Colleagues</u> in UAPPOL

<u>Non-Academic staff</u> – as defined by the <u>Recruitment Policy (Appendix B) Definition and Categories of</u> <u>Support Staff</u> in UAPPOL

# GFC Academic Planning Committee Terms of Reference

# 1. Authority

The *Post-Secondary Learning Act* gives General Faculties Council (GFC) responsibility, subject to the authority of the Board of Governors, over "academic affairs" (section 26(1)). Section 26(1)(o) provides that GFC may make recommendations to the Board of Governors on a number of matters, including "the budget" and "academic planning." GFC has thus established an Academic Planning Committee (GFC APC), as set out below. GFC delegates certain of its powers to the GFC Academic Planning Committee.

The complete wording of the section(s) of the *Post-Secondary Learning Act*, as referred to above, and any other related sections, should be checked in any instance where formal jurisdiction or delegation needs to be determined.

# 2. Composition of the Committee

- Provost and Vice-President (Academic), Chair
- Vice-President (Research)
- Vice-President (Finance & Administration)
- President of the Students' Union
- President of the Graduate Students' Association

# Members Elected by General Faculties Council

- Four academic staff elected by and from GFC (Category A1.1 and A1.6 and their counterparts in A1.5 and A1.7)
- Two academic staff-at-large (Category A1.1 and A1.6 and their counterparts in A1.5 and A1.7)
- One NASA member (Category S1.0) at-large
- One Dean
- One Department Chair-at-large
- One undergraduate student-at-large
- One graduate student-at-large

# Non-Voting Members

- One faculty member of the GFC Executive, appointed by the Chair of the GFC Executive.
- The Provost and Vice-President (Academic) may ask any resource person to attend for any item(s). It is recognized the Vice-Provost and University Registrar will routinely be in attendance at APC as a non-voting observer/resource person. (GFC 29 SEP 2003)

NOTE: APC will elect one of the APC academic staff members to serve as Vice-Chair. APC shall appoint one of its elected faculty members as a cross-representative to the FDC. The President, as Chair of GFC, may attend at his or her discretion any meeting of APC in order to present any item or to receive advice from APC.

# 3. Mandate of the Committee

The Academic Planning Committee (APC) is GFC's senior committee dealing with academic, financial and planning issues. As such, it is not only responsible to GFC (or the Board) for the specific matters itemized below, but may also ask to consider or recommend to GFC on any academic issue, including 1) those issues under the purview of other GFC committees, 2) any academic issue related to restructuring, 3) any research-related issue, or 4) issues linked to academic service units where those issues have a significant academic impact. In like manner, the President, Provost and Vice-President (Academic) or other Vice-Presidents may refer any matter to APC for consideration or recommendation to GFC. APC is also responsible to GFC for promoting an optimal learning environment for students and excellence in teaching, research, and graduate studies. (GFC 29 SEP 2003)

APC is responsible for making recommendations to GFC and/or to the Board of Governors concerning policy matters and action matters with respect to the following:

### 1. Planning and Priorities

To recommend to GFC and/or the Board of Governors on planning and priorities with respect to the University's longer term academic, financial, and facilities development. (GFC 29 SEP 2003)

#### 2. Units

a. Subject to Article 32 of the Faculty Agreement, to recommend to GFC on the establishment and termination of Faculties, Departments, Schools and divisions, and on mergers involving Faculties, Departments or Schools. (Divisions are defined as academic units with authority over student programs. They may be budgetary units and may or may not be part of an existing Department.)

With respect to any proposal to terminate, merge or reorganize a Faculty, Department or School, the Provost and Vice-President (Academic) will ensure that before a proposal is placed before APC, the Dean(s) is notified, provided with supporting documentation, and is given a reasonable amount of time to take the matter to the Faculty Council(s).

b. To recommend to the Board of Governors on the assignment of priorities for the establishment of new Faculties, Departments or Schools, and on the establishment, merger, or termination of support units, except ancillary units.

c. To receive and discuss recommendations from the President or the appropriate Vice-President concerning reviews of campus units and to take appropriate action.

#### 3. Enrollment and Planning

a. To recommend to GFC on University-wide enrollment targets for undergraduate and graduate students.

b. To recommend to GFC on enrollment management processes, including the establishment of new quotas for individual Faculties and programs.

c. To recommend to the Board of Governors on changes to existing quotas for individual Faculties or programs.

#### 4. Budget Matters

a. To recommend to GFC on budget principles.

b. To recommend to the Board of Governors on the annual budget, excluding budgets for ancillary units.

c. To seek the recommendation of GFC regarding any new fee that will be levied upon a substantial group of students, prior to the recommendation by APC of any such fees to the Board of Governors. (A substantial group of students is defined as any one (or all) of the following three classes of students: (a) undergraduate students, (b) doctoral level students, and/or (c) graduate students pursuing studies other than those at doctoral level.)

Note: On February 12, 1996, General Faculties Council agreed that:

a. An information session on the proposed budget take place at GFC each year just prior to being introduced to the [APC] and Board approval process; and b. Information, however 'soft,' be provided to GFC at its first meeting in September. (GFC 12 FEB 1996)

#### 5. Facilities

a. To recommend to the Board of Governors on policy matters regarding the planning and use of physical facilities. (GFC 29 SEP 2003)

b. To recommend to the Board of Governors on policy matters regarding the use of land owned or leased by the University. (GFC 29 SEP 2003)

c. To recommend to the Board of Governors on policy matters regarding standards, systems and procedures for planning and designing physical facilities.

d. To recommend to the Board of Governors on matters regarding planning and use of physical facilities where these facilities are deemed to have a significant academic and/or financial impact on the University. (The determination of what constitutes a "significant academic and/or financial impact" will be made by the Provost and Vice-President (Academic).

#### 6. Teaching and Learning

a. To recommend to GFC on broad policy directions for excellence in teaching and learning in a manner that ensures accountability of all Faculties in this matter.

b. To receive and discuss advice and/or recommendations from the GFC Committee on the Learning Environment, when provided, and to take appropriate action. (GFC 29 SEP 2003)

# 7. Admission, Transfer and Academic Standing

a. To consider advice or recommendation from the GFC ASC on proposals for the establishment of or change to general University admission or transfer policies affecting students, including policies affecting Open Studies students, and to act for GFC in approving policies which in APC's view are minor or routine; and to recommend to GFC on proposals involving major change

b. To consider advice or recommendation from the GFC ASC on proposals which involve substantial change to admission/transfer regulations or to academic standing regulations.

#### 8. Establishment/Termination of Academic Programs

NOTE: APC deals with major program matters; minor program matters are dealt with through the GFC-mandated course/program approval process. The Provost and Vice-President (Academic) decides what is major or minor.

a. To approve the establishment of new academic programs at the University of Alberta or those administered in cooperation with other post-secondary institutions.

b. To recommend to GFC on the termination of academic programs at the University of Alberta or those administered in cooperation with other post-secondary institutions. (GFC 27 MAY 2002)

c. To receive advice and comment from FDC on any facilities-related matter which may affect academic programs normally before an academic program proposal is considered by APC. Facilities-related matters may include requests for additional space or major new construction projects.

d. Where additional funding and/or space is required to support the offering of a proposed certificate and/or if, in the opinion of the Provost and Vice-President (Academic) the certificate required Government approval, ASC would provide a recommendation on the (proposed) initiative to APC. APC, in turn, would have the GFC delegated authority to give final approval for the proposal in those cases where Government approval of the certificate is not required; in cases where Government approval is required, APC would provide recommendation on the proposal to the Board of Governors (or delegate body). (GFC 31 MAY 2005).

# 9. Name Changes of Faculties, Departments, and Divisions

- a. To recommend to GFC on proposals to change the names of Faculties.
- b. To approve name changes of Departments and divisions.

# 10. Endowed and Funded Chairs

To establish or terminate endowed and funded chairs.

# 11. Centres and Institutes

All proposals for establishment of academic centres and institutes shall be submitted in accordance with University policy and procedure as set out in the University of Alberta Policies and Procedures Online (UAPPOL). (GFC 27 MAY 2002)

# 12. Graduate Degree Specializations

All proposals for establishment of graduate degree specializations shall be submitted to the Dean of the Faculty of Graduate Studies and Research. The Dean, after consultation, may approve proposals which do not involve base operating or capital funds; the Dean will report these approvals to APC. Proposals which constitute new programs and/or which do involve base operating or capital funds will be considered and decided upon by APC.

13. Existing Undergraduate and Graduate Academic Programs:

- Extension and/or Substantive Revision of Existing Programs

- Revisions to or Extension of Existing Degree Designations

All proposals for major changes to existing undergraduate and graduate programs (eg, new degree designation, new curriculum) shall be submitted to the Provost and Vice-President (Academic). (Minor program changes are circulated for challenge to interested parties as set out in Section 37 of this Manual.) In cases where it is not clear if a change is major or minor, the Vice-President (Academic) will decide.

The Provost and Vice-President (Academic), after consultation with relevant Offices, committees or advisers will place the proposal before APC. APC has the final authority to approve such proposals unless, in the opinion of the Vice-President (Academic), the proposal should be forwarded to GFC with an attendant recommendation from APC. The Provost and Vice-President (Academic) may seek the advice of FDC on space-related matters inherent to the proposal prior to its consideration by APC.

Where additional funding and/or space is required for new non-credit programs and program expansions in the Faculty of Extension, the GFC ASC will recommend to APC.

# 14. Diploma Programs Offered by Centre collègial de l'Alberta de l'University of Alberta

GFC delegates to APC the sole authority to consider and approve proposals from Centre collègial de l'Alberta de l'University of Alberta for the establishment of or termination of diploma programs (including all admission/transfer, academic standing/graduation, and related matters) to be offered by this unit. Where a new funding model is proposed for a new or existing diploma program, however, APC will forward the proposal (with recommendation) on to the appropriate standing committee of the Board of Governors. (GFC EXECUTIVE COMMITTEE 03 DEC 2012)

#### 15. Other

a. To recommend to the Board of Governors and/or GFC on any other matter deemed by APC to be within the purview of its general responsibility.

b. To decide on any routine academic matters not already covered by GFC's delegations to the Provost and Vice-President (Academic) or its other committees.

- 4.3 Physical Testing and Immunization of Students
  - a. Approve individual Faculty regulations concerning physical testing and immunization of students.
- 4.4 Credit and Non-Credit Certificates
  - a. Approve the establishment and termination of credit and non-credit certificates subject to resource limitations.
- 4.5 Faculty of Extension Non-Credit Programs
  - a. Approve new non-credit programs and program expansions in the Faculty of Extension subject to resource limitations
  - b. Decide on any challenge made to an Extension non-credit course which the Provost and Vice-President (Academic) has been unable to resolve.

# 5. Responsiblities Additional to Delegated Authority

- 5.1 Calendar
  - a. Provide advice to the GFC Executive Committee (EXEC) on the preparation and publication of the University Calendar
- 5.2 Admissions, Transfer, and/or Academic Standards Regulations
  - a. Recommend to GFC on changes to admissions, transfer and/or academic standards regulations with institutional scope
  - b. Receive and discuss the Report of the Senate Committee of Lay Observers of the Admissions Process in Quota Programs
- 5.3 Program Proposals
  - a. Review new program proposals and substantial revisions to programs, and provide recommendations to the GFC Academic Planning Committee (APC)
  - b. Review and recommend program suspensions and terminations to APC

# 6. Sub-delegations from the GFC Academic Standards Committee

Should be reviewed at least every three years and reported to GFC.

  - a. Where additional funding and/or space is required, ASC would provide a recommendation on the proposed program to APC

# 8. Reporting

8.1 The Committee should regularly report to GFC with respect to its activities and decisions.

8.2 The Committee should report on approved changes to individual Faculty regulations concerning physical testing and immunization of students to EXEC for information.

8.3 The Committee should report annually to APC on new and terminated certificates.

# 9. Definitions

Routine and/or Editorial - refers to proposals which do not involve or affect other Faculties or units and do not form part of a proposal for a new program. Editorial or routine changes include any and all changes to the wording of faculty or program specific admissions or academic standing regulations.

Substantial - refers to proposals which involve or affect more than one Faculty or unit; are part of a proposal for a new program; are likely to have a financial impact; represent a definite departure from current policy; involve a quota; articulate a new academic concept.

Dispute - If there is any dispute or question as to which of the above categories a proposal falls under, the Provost and Vice-President (Academic) (or delegate) will decide.

Embedded Certificate – Defines a specific area of focus for the student and is completed during the course of an undergraduate or graduate degree program.

Free-standing Credit Certificate – Stand-alone programs at the undergraduate or graduate level.

Free-standing Non-Credit Certificate – Stand-alone programs for professional development and continuing education.

# **GFC Academic Standards Committee Terms of Reference**

# 1. Authority

The *Post-Secondary Learning Act* gives General Faculties Council (GFC) responsibility, subject to the authority of the Board of Governors, over "academic affairs" (section 26(1)). Further, the *Post-Secondary Learning Act* (sections 60(1)(c) and (d)) gives the Board of Governors authority over certain admission requirements and rules respecting "enrolment of students to take courses." The Board has delegated its authority over these areas to GFC. GFC has thus established an Academic Standards Committee (GFC ASC), as set out below, and has delegated certain of its powers to the GFC ASC.

The complete wording of the section(s) of the *Post-Secondary Learning Act*, as referred to above, and any other related sections, should be checked in any instance where formal jurisdiction or delegation needs to be determined.

# 2. Composition of the Committee

# **Ex Officio**

Provost and Vice-President (Academic) (or delegate); (Chair) (GFC 31 MAY 2005) Dean (or delegate) of each Faculty or School; Vice-Provost and University Registrar (or delegate) Students' Union Vice-President (Academic) (or delegate); Graduate Students' Association Vice-President (Academic) (or delegate) (GFC 29 SEP 2003) (GFC 31 MAY 2005) Director of the Student Ombudservice (or delegate)

# **Elected Members**

One academic staff member (Categories A1.1 and A1.6 and their counterparts in A1.5 and A1.7\*) elected by GFC (GFC 29 SEP 2003)

One undergraduate student elected by GFC, who may be a transferee from an Alberta College

# **Appointed Member**

A representative of the Health Sciences Council, appointed by the Council (GFC 29 SEP 2003)

\* See UAPPOL Recruitment Policy (Appendix A) Definition and Categories of Academic Staff.

# **Non-Voting Members**

Associate Registrar (or delegate) (GFC 29 SEP 2003) (GFC 31 MAY 2005) The Chair of the GFC Academic Appeals Committee (or delegate) (EXEC 03 FEB 2003) University Advisor – International Educational Experiences (EXEC 04 OCT 2010)

# **Chair and Vice-Chair**

ASC is chaired by the Provost and Vice-President (Academic) or delegate. A faculty member from among the *ex-officio* membership, appointed by the Chair, will serve as Vice-Chair. (EXEC 06 OCT 2008)

Normally the Chair of ASC (or delegate) will serve as the University's representative on the Alberta Council on Admissions and Transfer (ACAT). (EXEC 06 JUN 1984) (GFC 26 JAN 1987) (GFC 26 JUN 1989)

# 3. Mandate of the Committee

The ASC is responsible for making recommendations and/or for providing advice to GFC, its Executive Committee, and/or the GFC Academic Planning Committee (APC) on the matters set out below, which include such areas as admissions and transfer, including admission and transfer to Faculties, admission of Open Studies students, academic standing policies and general university admission policies, and all institutional marking and grading policies and/or procedures. (GFC 29 SEP 2003) (GFC 31 MAY 2005)

# A. Definitions

# i. "Routine and/or Editorial"

In the responsibilities which follow, the term "routine and/or editorial" refers to proposals which do not involve or affect other Faculties or units; do not form part of a proposal for a new program; and which do not involve alteration of an existing quota or establishment of a new quota. Editorial or routine changes include any and all changes to the wording of an admissions or academic standing policy.

# ii. "Substantial"

In the responsibilities which follow, the term "substantial" refers to proposals which involve or affect more than one Faculty or unit; are part of a proposal for a new program; are likely to have a financial impact; represent a definite departure from current policy; involve a quota; articulate a new academic concept.

# iii. Dispute

If there is any dispute or question as to which of the above categories a proposal falls under, the Provost and Vice-President (Academic) (or delegate) will decide. (GFC 31 MAY 2005)

# B. Admission and Transfer, Academic Standing, Marking and Grading, Term Work, Examinations, International Baccalaureate (IB), Advanced Placement (AP)

i. All proposals from the Faculties or the Administration related to admission and transfer, to the academic standing of students, to institutional marking and grading policies and/or procedures and to term work policies and procedures are submitted to the Provost and Vice-President (Academic) (or delegate) who chairs the GFC Academic Standards Committee. ASC will consult as necessary with the Faculties and with other individuals and offices in its consideration of these proposals. (GFC 29 SEP 2003) (GFC 31 MAY 2005) (EXEC 04 DEC 2006)

ii. ASC acts for GFC in approving routine and/or editorial changes to both admission/transfer policies and academic standing regulations, and acts for GFC in approving all proposals for a) change to examination regulations, b) change to existing International Baccalaureate (IB) and Advanced Placement (AP) policies and procedures and c) change to the *University Calendar* Section on Missed Term Work (under the Section entitled *Evaluation Procedures and Grading System*. (EXEC 18 NOV 1996) (EXEC 04 DEC 2006)

iii. In consultation with the Office of the Provost and Vice-President (Academic) and the Office of the Registrar and Student Awards, ASC monitors the implementation of the consolidated final examination policy.

iv, ASC provides advice or recommends to the GFC Academic Planning Committee (APC) on proposals which involve substantial change to admission/transfer regulations or to academic standing regulations.

v. ASC provides advice or recommends to APC on general University admission or transfer policies affecting students, including policies which affect Open Studies.

vi. ASC provides advice or recommends to the GFC Executive Committee on institutional marking and grading policies and/or procedures.

vii. ASC provides advice or recommends to the GFC Executive Committee on institutional term work policies and/or procedures (with the exception of that noted in B. ii).

viii. ASC maintains a dialogue with the Provost and Vice-President (Academic) on major admission/transfer and academic standing issues. (GFC 29 SEP 2003)

ix. ASC maintains a dialogue with secondary and other post-secondary institutions, as requested by the Provost and Vice-President (Academic). (GFC 31 MAY 2005)

x. ASC responds to proposals that may affect the admission or transfer of students to the University of Alberta.

xi. ASC acts for GFC in approving either of the following kinds of proposed changes to courses **recommended or required for admission**: a. a course previously recommended for admission is now required for admission; or b. a course previously required for admission is now only recommended for admission.

# C. Quotas

i. Proposals which involve a new quota or a revision to an existing quota are submitted to the Provost and Vice-President (Academic) (or delegate) for consideration by the GFC Academic Planning Committee (APC); ASC's advice will be sought on the admissions/ transfer component of such proposals. (GFC 29 SEP 2003) (GFC 31 MAY 2005)

ii. ASC undertakes studies on the effects of admission/transfer requirements, and where such studies involve quotas, consults with the Provost and Vice-President (Academic).

iii. ASC receives annually and considers the Report of the Senate Committee of Lay Observers of the Admissions Process in Quota Programs. (GFC 29 SEP 2003)

# D. Alberta Transfer Guide

i. ASC approves, for inclusion in the Alberta Transfer Guide, courses for transfer credit to the University of Alberta which are offered by non-University institutions in Alberta. Approval will be based upon an assessment of course content and level of instructor qualifications.

ii. ASC denies courses for transfer credit to the University of Alberta which are offered by non-University institutions in Alberta.

iii. ASC monitors the entries in the Alberta Transfer Guide relevant to the University of Alberta.

iv. ASC rescinds, if necessary, the entries in the Alberta Transfer Guide relevant to the University of Alberta.

# E. Physical Testing and Immunization of Students

ASC approves on GFC's and the Board's behalf, all individual Faculty policies concerning physical testing and immunization of students, and files a report with the GFC Executive Committee for information. (GFC 27 SEP 1999) (GFC 29 SEP 2003)

# F. Faculty of Extension Courses and Programs: Approval Route

i. GFC delegated to ASC the authority to approve new non-credit programs and program expansions in the Faculty of Extension. Where additional funding and/or space is required, ASC would provide a recommendation on the proposed program to the GFC Academic Planning Committee (APC); (GFC 29 SEP 2003)

ii. GFC delegated to the Provost and Vice-President (Academic) the authority (a) to approve new non-credit courses or major changes in the content or delivery of existing non-credit courses in the Faculty of Extension and (b) to receive and resolve challenges concerning these courses. (GFC 29 SEP 2003)

iii. GFC delegated to ASC the authority to make a decision on any challenge made to an Extension non-credit course which the Provost and Vice-President (Academic) has been unable to resolve. (GFC 30 MAR 1981) (GFC 29 SEP 2003)

iv. Credit programs and courses in the Faculty of Extension will follow the normal route as outlined in policies on course and program changes. (GFC 29 SEP 2003)

# G. Certificates (All Faculties): Approval Route

GFC delegated to ASC the authority to approve proposals for the establishment of and termination of credit and non-credit certificates, regardless of the proposing academic unit. Where additional funding and/or space is required to support the offering of the proposed certificate and/or if, in the opinion of the Provost and Vice-President (Academic) (or delegate), the certificate requires Government approval, ASC would provide a recommendation on the (proposed) initiative to the GFC Academic Planning Committee (APC). (GFC 31 MAY 2005) (EXEC 12 JAN 2009)

# H. Other Matters

The Chair of ASC will bring forward to ASC items where the Office of the Provost and Vice-President (Academic), in consultation with other units or officers of the University, is seeking the advice of the Committee. These matters may include, but are not limited to, those related to academic advisement, official University academic records keeping, discipline, student services, publication of the University Calendar, the continuation of, or major changes to, existing affiliation agreements and proposals for new affiliation agreements between other postsecondary institutions and the University of Alberta, and registration. (GFC 29 SEP 2003) (GFC 31 MAY 2005)
