Course Description, Objectives and Expected Learning Outcomes:

This course is a survey of the dystopian novel from a historical and cross-cultural perspective as one of the influential and distinctive genres of contemporary literature. The course explores the evolution of dystopian fiction and representation of dystopia across the media in the light of socio-political, technological, and environmental changes with a specific focus on the second half of the 20th century and beyond. Students will examine a wide range of representative contemporary texts from a variety of cultural and linguistic contexts. By the end of this course successful students will be able to identify and discuss representative characteristics and themes of the contemporary dystopian novel as a global form; develop a theoretical vocabulary for discussing the

genre; recognize the diverse audiences and ideological functions of this literary form; and present an analysis of the text(s) of their choice in a specific cultural and sociopolitical context.

Course Format: The objectives of this course will be achieved through a combination of formal lectures, assigned readings and audiovisual materials, class discussions and presentations.

Explanatory Notes on Assignments:

Critical Response Paper: The paper is expected to be approximately 500-600 words long and show your critical engagement with the text in question. Because this is a short assignment, the paper is expected to offer a narrowly focused critical discussion/analysis of a specific aspect of the text of your choice from the class reading list.

Presentation is expected to be about 10-12 min. long. It is a focused discussion of a specific topic related to one of the texts from the class reading list. Students will sign up for topics throughout the term. All presentation topics must be approved by the instructor.

Midterm Examination follows an essay format. You will be asked to provide a critical analysis of one or more texts covered in class. The examination assignment will provide a selection of questions to choose from.

Final Project Proposal includes a paragraph-long description of the essay topic, a tentative thesis statement, and a list of secondary sources to be used in the essay.

Final Project is a research essay (about 2500 words) where you are expected to present a critical, contextualized analysis of the primary source(s) of your choice. A research essay will allow you to develop a more complex argument (compared to a critical response paper) and engage with the current scholarship on the subject.

Attendance and participation mark includes attendance, preparedness with readings and informed participation in class discussions.
